# HB 268 ON THIRD READING (by Keel)

**HB 268**, A bill to be entitled An Act relating to the qualifications and appointment of counsel for indigent defendants in capital cases.

#### Amendment No. 1

Representative Keel offered the following amendment to **HB 268**:

Amend **HB 268** (2nd Reading Engrossment) on third reading as follows:

(1) On page 1, line 5, strike "Sections 2(c) and (d)" and substitute "Section 2".

- (2) On page 1, line 6, strike "are amended" and substitute "is amended by amending Subsections (c) and (d) and adding Subsection (d-1)".
- (3) Strike the language on page 1, line 21, through page 2, line 18, and substitute the following:
- (d) (1) The <u>Task Force on Indigent Defense</u> [eourt of criminal appeals] shall adopt <u>standards</u> [rules] for the appointment of attorneys as counsel under this section [and the convicting court may appoint an attorney as counsel under this section only if the appointment is approved by the court of criminal appeals in any manner provided by those rules].
- (2) The standards must require that an attorney appointed as lead counsel under this section:
  - (A) be a member of the State Bar of Texas;
- (B) exhibit proficiency and commitment to providing quality representation to defendants in death penalty cases;
- (C) have participated in continuing legal education courses or other training relating to criminal defense in death penalty cases;
- (D) not have been found by a federal or state court to have rendered ineffective assistance of counsel during the trial or appeal of any criminal case;
- (E) have at least five years of experience in criminal trial or appellate litigation or habeas corpus practice; and
- (F) have participated in the preparation of appellate briefs for the prosecution or defense, or in the drafting of appellate opinions as a staff attorney for an appellate court, in felony cases, including homicide cases and other cases involving an offense punishable as a capital felony or a felony of the first or second degree.
- (3) The Task Force on Indigent Defense shall maintain a list of attorneys qualified for appointment under this section and make that list available to a convicting court for the purpose of assisting that court with the appointment of qualified counsel under this section.
  - (4) On page 2, between lines 25 and 26, insert the following:
- (d-1) The court of criminal appeals may annually review the list of attorneys qualified for appointment under this section to ensure that the attorneys included on the list are suitably qualified and proficient to be eligible for appointment. The court may determine whether an attorney is eligible for appointment on a case-by-case basis. The court may remove an attorney from the list if the attorney is determined to be ineligible for appointment.

  - (8) Strike page 6, line 25, through page 7, line 7, and substitute:
- (b-1) If the insurer or provider cancels the reimbursement insurance policy, the provider named on the policy may not issue a new service contract after the effective date of the cancellation unless:
- (1) the provider files with the executive director a copy of a new policy that meets the requirements of this section and that provides coverage after that date; or
- (2) the provider complies with other financial security requirements provided by Section 1304.151(a)(2).
  - (9) Strike page 7, lines 15-18.
  - (10) On page 7, line 19, strike "(f)" and substitute "(e)".

### HB 840 - (consideration continued)

### Amendment No. 1

Representative Dutton offered the following amendment to **HB 840**:

Amend **HB 840** on 3rd Reading by adding an appropriately numbered section to read as follows and by renumbering existing sections accordingly:

SECTION \_\_\_\_. Article 59.02, Code of Criminal Procedure, is amended by adding Subsection (j) to read as follows:

- (j) Notwithstanding any other provision of this chapter, community property, property that is jointly owned, or property that was loaned by the owner or interest holder to another person for a reason other than to facilitate the commission of an offense is not subject to forfeiture if the spouse, joint owner, or owner or interest holder establishes by a preponderance of the evidence that:
- (1) the spouse, joint owner, or owner or interest holder was not a party to the offense; and
- (2) the actor in the criminal offense used or intended to use the property without the effective consent of the spouse or joint owner or used or intended to use the property in a manner not reasonably foreseen by the person loaning the property.

Amendment No. 1 was adopted.
