SB 427 ON THIRD READING (Vo and Denny - House Sponsors)

SB 427, A bill to be entitled An Act relating to providing notification to a county voter registrar of the change in boundaries of a political subdivision located in the county.

Amendment No. 1

Representative Vo offered the following amendment to **SB 427**:

Amend **SB 427** on third reading by striking Article 2 of the bill, as added by the Hardcastle amendment, and renumbering the remaining articles as appropriate.

Amendment No. 1 was adopted.

SB 91 ON THIRD READING (Riddle - House Sponsor)

SB 91, A bill to be entitled An Act relating to the punishment imposed on certain defendants charged with the offense of assault.

Amendment No. 1

Representative Riddle offered the following amendment to SB 91:

Amend **SB 91** on third reading by adding the following appropriately numbered SECTIONS to the bill and renumbering existing SECTIONS of the bill accordingly:

SECTION __. Article 14.03(a), Code of Criminal Procedure, as amended by Section 2, Chapter 460, Section 2, Chapter 836, Section 1, Chapter 989, and Section 2, Chapter 1164, Acts of the 78th Legislature, Regular Session, 2003, is reenacted and amended to read as follows:

- (a) Any peace officer may arrest, without warrant:
- (1) persons found in suspicious places and under circumstances which reasonably show that such persons have been guilty of some felony, violation of Title 9, Chapter 42, Penal Code, breach of the peace, or offense under Section 49.02, Penal Code, or threaten, or are about to commit some offense against the laws:
- (2) persons who the peace officer has probable cause to believe have committed an assault resulting in bodily injury to another person and the peace officer has probable cause to believe that there is danger of further bodily injury to that person;

- (3) persons who the peace officer has probable cause to believe have committed an offense defined by Section 25.07, Penal Code (violation of Protective Order), or by Section 38.112, Penal Code (violation of Protective Order issued on basis of sexual assault), if the offense is not committed in the presence of the peace officer; [or]
- (4) persons who the peace officer has probable cause to believe have committed an <u>offense involving family violence</u>; [assault resulting in bodily injury to a member of the person's family or household; or]
- (5) persons who the peace officer has probable cause to believe have prevented or interfered with an individual's ability to place a telephone call in an emergency, as defined by Section 42.062(d), Penal Code, if the offense is not committed in the presence of the peace officer; or [-]
- (6) [5] a person who makes a statement to the peace officer that would be admissible against the person under Article 38.21 and establishes probable cause to believe that the person has committed a felony.

SECTION __. Articles 14.03(c) and (f), Code of Criminal Procedure, are amended to read as follows:

- (c) If reasonably necessary to verify an allegation of a violation of a protective order or of the commission of an offense involving family violence [assault against a member of the family or household], a peace officer shall remain at the scene of the investigation to verify the allegation and to prevent the further commission of the violation or of family violence.
- (f) In this article, <u>"family violence" has ["family," "household," and "member of a household" have</u>] the <u>meaning [meanings]</u> assigned [to those terms] by <u>Section 71.004</u> [Chapter 71], Family Code.

Amendment No. 1 was adopted.

SB 945 ON THIRD READING (Morrison - House Sponsor)

SB 945, A bill to be entitled An Act relating to the filing of a disclosure statement by a vendor or member of a governing body of a port authority or navigation district; imposing a penalty.

Amendment No. 1

Representative Morrison offered the following amendment to SB 945:

Amend **SB 945** as follows:

- 1. On page 1, line 24 amend SECTION 1, Subchapter P, Sec. 60.483(a)(2) of the bill by inserting "negotiations of" between the words "with" and "a".
- 2. On page 2, line 9 amend SECTION 1, Subchapter P, Sec. 60.483(c)(1) of the bill by deleting "discussions or" between the words "contract" and "negotiations".

- 3. On page 4, line 7 amend SECTION 1, Subchapter P, Sec. 60.484(c)(2) of the bill by deleting "considering conducting business" between the words "is" and "with" and substitute "negotiating a contract".
- 4. On page 4, line 19 amend SECTION 1, Subchapter P, Sec. 60.484(e) of the bill by deleting "has" between the words "body" and "violated" and substitute "knowingly".

SB 898, A bill to be entitled An Act relating to tax liability for property omitted from an appraisal roll.

Amendment No. 1

Representative Truitt offered the following amendment to SB 898:

Amend **SB 898** on third reading by inserting the following appropriately numbered section and renumbering the subsequent sections of the bill accordingly:

SECTION __. Section 31.01(a), Tax Code, is amended to read as follows:

(a) Except as provided by Subsection (f), the assessor for each taxing until shall prepare and mail a tax bill to each person in whose name the property is listed on the tax roll and [or] to the person's authorized agent. The assessor shall mail tax bills by October 1 or as soon thereafter as practicable. The assessor shall mail to the state agency or institution the tax bill for any taxable property owned by the agency or institution. The agency or institution shall pay the taxes from funds appropriated for payment of the taxes or, if there are none, from funds appropriated for the administration of the agency or institution. The exterior of the tax bill must show the return address of the taxing unit and must contain, in all capital letters, the words "RETURN SERVICE REQUESTED," or another appropriate statement directing the United States Postal Service to return the tax bill if it is not deliverable as addressed.

- (c-2) If the use of alternative energy devices for a specific function is determined to be economically feasible under Subsection (c-1), the governing body shall include the use of alternative energy devices for that function in the construction plans for the project.

- (d) The commission may impose an administrative fine on an entity that operates a vending machine subject to this section in an amount not to exceed \$250 a year for each machine found to be in violation of this section or related rules adopted by the commission.
- (e) The commission shall adopt rules relating to the specifications for and regulation of energy-saving devices required by this section.
- SECTION __. (a) An entity that owns or operates a vending machine subject to Section 2165.058, Government Code, as added by this Act, is not required to comply with that section or a related rule of the Texas Building and Procurement Commission until September 1, 2006.
- (b) Notwithstanding Section 2165.058(d), Government Code, as added by this Act, the Texas Building and Procurement Commission may impose a fine only in relation to a vending machine that is found to be operating in violation of Section 2165.058, Government Code, as added by this Act, or a related rule of the commission, on or after September 1, 2006.

(2) "Endorsing Municipality" means a municipality [that has a population of one million or more and] that contains a site selected by a site selection organization for one or more games.

SECTION 2. Section 5A(q), Chapter 1507, Acts of the 76th Legislature, Regular Session, 1999 (Article 5190.14, Vernon's Texas Civil Statutes), is repealed.

SECTION 3. This Act takes effect September 1, 2005.
