ADDRESS BY REPRESENTATIVE VEASEY

The chair recognized Representative Veasey who addressed the house, speaking as follows:

Members, I first want to recognize Mrs. Ruby Session, who is the mother of Timothy Cole, and his uncle, Mr. Benny Cole, who is also here.

This was a really sad case that occurred back in the early 80s. I first read about this in the *Star Telegram*. The first thing that came to mind is, during the 80s in Fort Worth, we had something similar happen. There was a rapist in the TCU area, and I remember how it paralyzed the entire city. Everybody in Fort Worth was scared, and so I know that in Lubbock they really wanted to catch the perpetrator of this crime, and unfortunately the wrong person was convicted of a crime.

Timothy Cole was a veteran. He was someone that served his country. He was someone that wanted to live the American dream, and so he went to Texas Tech University to try to further that American dream by gaining a college degree. That goal was cut short by a wrongful conviction. He had a clean criminal record. Oftentimes, when you hear about people who are wrongly convicted, it's because they match some sort of MO or match some description. So, a person is wrongly convicted because of something they did in the past, but Timothy Cole had a zero record—completely clean. It was really unfortunate that he had to spend the rest of his life in the Texas penal system.

Upon his conviction, the real perpetrator happened to be in jail, and they were investigating him for another crime. He heard Timothy Cole crying in his jail cell because Timothy always thought that he would be proven innocent. He was actually offered a deal where he could have served no time in prison, and he turned that deal down. Every time he went before the parole board, he was told that he could probably get out on parole if he would just admit that he was the perpetrator, but he would never do it. He wanted to maintain his innocence. He always knew that one day he would be proven innocent, but unfortunately it was too late, and he died behind prison bars.

The person who admitted to doing the crime wrote letters to the district attorney's office. They were ignored. He finally wrote a letter to the family, and that's when this all came to light. There is an article today in *USA Today*, and there is also an editorial in the *Austin American-Statesman*.
