#### STATEMENT BY REPRESENTATIVE J. WHITE

Representative J. White submitted the following statement for inclusion in the journal:

Our state's accountability system is seriously broken, and **SB 149** puts a band-aid on the problem instead of resolving the issues with the evaluation system. After hearing the concerns from high education interests, the business community, and other reform education advocates, the legislature decided to tie graduation to successful passage of 15 end-of-course exams. After rigorous review, the validity of these exams ensured that passage signaled that high school graduates were college and career ready.

Based on reports, the initial stages of the implementation process was less than optimal. The resources needed to facilitate successful passage of these tests did not arrive on time. Because of that and other reasons, the Texas Education Agency delayed the full implementation of end-of-course exams for two years. As students began taking the courses, the pass-fail rates were sobering, and the prospect of thousands of students needing to remediate and retake multiple tests was alarming. More so, the optic of the State of Texas denying thousands of 12th graders that attended our schools for 12 years and earned promotion from grade to grade the opportunity to walk across the graduation stage disturbed many public policy makers, school administrators, parents, and students.

In response, the legislature in 2013 significantly reduced the number of tests that Texas public education students needed for graduation to five from 15. To include, providing more discretion to elected local school boards in implementing graduation opportunities congruent with their community's expectations and needs. With only a year in place, some are asking for another change: **SB 149**.

Now, we all know what the elephant in the room is concerning this issue. The issue is that we have an impractical educational accountability system. We have the state-approved curriculum: TEKS. We have teachers, and we charge them with the responsibility to teach according to the TEKS. We have always had final exams or end-of-course exams in high school. However, we never had the requirement, nor do we need the requirement that one test could cancel out 36 weeks of instruction and student effort. We are trying to do too much with this system. We have exams that measure college readiness: SAT/ACT.

Now, it is important for policy makers to know how well our young Texans are doing relative to the TEKS and other measures of student achievement. However, a simple approach is to count an EOC exam as 30 percent of the student's grade. In this way, even if a student does perfect work, the EOC still is needed for a passing grade. No single test should void a body of work over nine months unless the student's work is less than average.

**SB 149** does not solve the problem. It only perpetuates the problem. This is not how you execute academic standards by moving the target board biennially.

#### **HB 1 - MOTION TO INSTRUCT CONFEREES**

Representative Simpson moved to instruct the Conference Committee on **HB 1** to strictly adhere to the House Rules and constrain their conversations only to the matters in disagreement between the two chambers. The conferees are further instructed that before they discuss any item not in disagreement between the two bills, they obtain permission from the respective chambers before beginning those discussions or taking actions.

REPRESENTATIVE MURPHY: Dave, I want to make sure I know what your motion's doing—and we've seen this in the past. So if the house and senate budgets are apart, this says that you can't go above or below either one. Is that what your motion's doing here?

REPRESENTATIVE SIMPSON: That's right. It's saying that if there's a disagreement in, say, a program—you have \$100 million in the senate and \$50 million in the house—that it has to be resolved between those two bounds. You can't go to \$125 million, and you couldn't go to \$25 million. You could discuss it and take actions on it in between those two bounds; you can't go outside it.

MURPHY: But what if our line items don't line up with their line items? So if you were to take all the individual line items of this larger aggregate amount you might have a larger number. What's the path forward on that?

SIMPSON: The path forward, according to Rule 13, Section 9, which limits the jurisdiction of conference committees, is to come back to each chamber and to ask for permission to go outside the bounds. So if they couldn't come to a result on that particular program, so they needed to go to \$105 million, they would come back to each chamber and ask it. They would probably do it for another

program, too. These things would happen with our permission—each of us having an opportunity to consider them and vote on them. So it's not just five members in the house and five members in the senate determining this.

MURPHY: So you're not trying to stop anything. You're just trying to keep the house part of the process of changing the budget from what we passed out?

SIMPSON: That's right. I'm trying to instruct the committee to do as the rules actually say and not sometimes, as we've done in practice, when we've actually sought forgiveness for discussing and taking action without at first gaining permission. It's interesting. In Rule 13, Section 9, it specifically addresses conference committees. It says conference committees on appropriations bills, like other conference committees, shall limit their discussions and their actions solely to the matters in disagreement between the two houses. In addition to the limitations contained elsewhere in the rules, a conference committee on appropriations bills shall be strictly limited in its authority. It itemizes those things, lists about five items, and then it says that the presiding officer, that is the speaker of the house, and the lieutenant governor, the presiding officer of the senate, shall strictly enforce those rules. So I'm asking the members of the conference committee to strictly abide by these rules.
