PARLIAMENTARY INQUIRY

REPRESENTATIVE STICKLAND: Mr. Speaker, yesterday I asked a series of parliamentary inquiries. I was wondering if we had the answers to that yet?

CHAIR (Hefner in the chair): Those issues are still being researched, Mr. Stickland.

STICKLAND: Do we have an estimation on how long that may take to get those?

CHAIR: We're looking at decades of house records and senate records, so not at this time.

STICKLAND: Do we anticipate getting them in the next couple of weeks?

CHAIR: We are trying to do this as quickly as possible.

STICKLAND: The parliamentarian, Mr. Griesel, is a licensed Texas attorney. To whom in this body, if anyone, does the parliamentarian owe a duty of loyalty or confidentiality?

CHAIR: Yes.

STICKLAND: Yes to what?

CHAIR: The reading clerk will read Rule 2, Section 9, regarding the parliamentarian's duties.

STICKLAND: When I was first elected, I was led to believe that the parliamentarian acts as an attorney for each of the members individually. Is that a correct understanding based on that rule that was just read?

STICKLAND: If a member seeks the advice of the parliamentarian regarding a procedural matter, does that parliamentarian owe a duty of confidentiality to that member regarding the matters discussed and the advice given?

STICKLAND: Does the parliamentarian owe any duty to the members to clarify his personal relationship with them as their attorney?

CHAIR: We're fairly certain that the members of the house were aware of this when the rules were adopted.

STICKLAND: Does the chair feel that anything needs to be done between the parliamentarian and the members individually outside of the rules that were adopted at the start of this session in regard to the relationship?

SPEAKER STRAUS: Good morning, Mr. Stickland. Will you restate the inquiry?
