SB 3, A bill to be entitled An Act relating to an appropriation to provide funding for the construction, operation, and maintenance of border barrier infrastructure and border security operations, including funding for additional overtime expenses and costs due to certain increased law enforcement presence.

- (c) The Trusteed Programs within the Office of the Governor may use money appropriated under Subsection (a) of this section to construct, operate, or maintain border barrier infrastructure only if the governor, in accordance with Sections 316.023 and 316.024, Government Code, makes a finding, after a public hearing, that the infrastructure proposed to be constructed, operated, or maintained is an effective means of significantly reducing the number of individuals unlawfully crossing this state's international border with Mexico.

SB 3 - STATEMENT OF LEGISLATIVE INTENT

REPRESENTATIVE RAYMOND: Chairman, thank you. During the last special session you were kind enough to confirm the legislative intent on **HB** 6 with respect to border mapping as part of the construction costs, and I wanted to just take a moment to confirm that intent for **SB** 3 as well.

SB 3 appropriates funds for the construction, operation, and maintenance of border barrier infrastructure as well as for border security operations. Is it your intent that any three-dimensional mapping or imaging the state needs to account for elevation, canopied areas hidden by trees, flood risks, et cetera along the border will be included as permissible uses of these funds?

REPRESENTATIVE JETTON: Yes, that's my understanding.

 - (i) lawful presence in the United States; or

- (2) "Port of entry" means a port of entry in the United States as designated by 19 C.F.R. Part 101.
- (b) The following federal programs do not constitute lawful presence for purposes of Subsection (a)(1)(A):
- (1) the Deferred Action for Parents of Americans and Lawful Permanent Residents program; and
- (2) any program not enacted by the United States Congress that is a successor to or materially similar to the program described by Subsection (a)(1)(B) or Subdivision (1).
 - (2) On page 5, strike lines 10-26, and substitute the following:
- (c) It is an affirmative defense to prosecution under this section that the defendant's conduct does not constitute a violation of 8 U.S.C. Section 1325(a).
