If the fee imposed under this section is pledged to the payment of obligations issued by Southmost Union Junior College district, the board of regents of The University of Texas System may not pledge revenue from the fee for the payment of obligations issued for an authorized purpose under the revenue financing system of The University of Texas System.

#### HCR 36 - REMARKS BY REPRESENTATIVE VO

In this Vietnam monument, we recognize and honor the ultimate sacrifice given by these soldiers in the name of love. It is for love that such brave men die. It is for love of country, of freedom, of what is right and just in the world, for love of humanity, for an individual's right to the pursuit of happiness. In our past, we must look beyond the struggle and loss to find illumination and will for our future. We must focus on the love given to us in the sacrifice of others and the love we must give in grace for those who would come after us. This monument symbolizes the eternal flame of love given in grace, the brightly burning belief in freedom and democracy, the flame that always burns inside ourselves in memory of those who fought and died in this war.

#### HCR 36 - REMARKS BY REPRESENTATIVE ESCOBAR

On behalf of all of you that served in that conflict, and on behalf of those that fought from this state of this great nation, and that died there. When we came back from Vietnam, members, we were not very well welcomed in this country. It is a pleasure to actually see us passing a resolution and having these young men and women, who are currently serving our country in war, stand over there as we suspend the rules to give them what is due for their service to their country. When we came back, we were not honored as such, but you know what—we overcame it. We were traumatized in many ways through war because we were kids, college kids. In my case, I was 18 years old when I got shot in Vietnam, and I was far away from home. I am from a small ranch instead of the big city so it was hard for me to understand what was happening. But I am very proud to have served my country. As a seventh generation Texan, I will fight for my country all the time. I will fight for this great state. Sometimes we have philosophical differences

as to the way we do things here, but it is because of the flag we defended there that we stand before you today as Vietnam veterans united, and with your help I hope we can pass this resolution. Thank you.
