**CONSTITUTIONAL AMENDMENTS CALENDAR  
HOUSE JOINT RESOLUTIONS  
SECOND READING**

The following resolutions were laid before the house and read second time:

**SJR 13 ON SECOND READING**

**(Berman, Naishtat, McReynolds, Flynn, Goolsby, et al.-House Sponsors)**

**SJR 13**, A joint resolution proposing a constitutional amendment authorizing the legislature to provide for a reduction of the limitation on the total amount of ad valorem taxes that may be imposed for public school purposes on the residence homesteads of the elderly or disabled to reflect any reduction in the rate of those taxes.

**SJR 13** was considered in lieu of **HJR 1**.

**Amendment No. 1**

Representatives B. Cook, Ritter, Otto, Villarreal, Keffer, and McReynolds offered the following amendment to **SJR 13**:

Amend **SJR 13** (house committee printing) as follows:

(1) Strike SECTION 1 of the joint resolution and substitute the following:

SECTION 1. Section 1-b, Article VIII, Texas Constitution, is amended by adding Subsection (d-1) to read as follows:

(d-1) Notwithstanding Subsection (d) of this section, the legislature by general law may provide for the reduction of the amount of a limitation provided by that subsection and applicable to a residence homestead for the 2007 tax year to reflect any reduction from the 2006 tax year in the tax rate for general elementary and secondary public school purposes applicable to the homestead. A general law enacted under this subsection may also take into account any reduction in the tax rate for those purposes from the 2005 tax year to the 2006 tax year if the homestead was subject to the limitation in the 2006 tax year. A general law enacted under this subsection may provide that, except as otherwise provided by Subsection (d) of this subsection, a limitation provided by that subsection that is reduced under the general law continues to apply to the residence homestead in subsequent tax years until the limitation expires.

(2) In SECTION 2 of the joint resolution, in Subsection (a) of the temporary provision of the Texas Constitution, between "taxes" and the underlined period (page 2, line 12), insert "for the 2006 and 2007 tax years".

(3) In SECTION 2 of the joint resolution, in Subsection (b) of the temporary provision of the Texas Constitution (page 3, line 14), strike "1-b(d)" and substitute "1-b".

(4) In SECTION 3 of the joint resolution, in the ballot proposition, between "taxes" and the period (page 4, line 3), insert "for the 2006 and 2007 tax years".

#### EMERGENCY CALENDAR HOUSE BILLS SECOND READING

**HB 2 ON SECOND READING**  
**(by Chisum and Hartnett)**

**HB 2**, A bill to be entitled An Act relating to making appropriations to the Texas Education Agency for the purpose of school district property tax rate reductions.

**HB 2 - STATEMENT OF LEGISLATIVE INTENT**

REPRESENTATIVE Y. DAVIS: Chairman Chisum, I want to ask a couple questions relative to the process—kind of the same lines that Scott was going. As it relates to doing this now, what is to do in terms of the appropriations process and having funds available to look at the various needs that the agencies are bringing before us, before you take this money out?

REPRESENTATIVE CHISUM: You're exactly right, but if we will raise that spending cap, it does not affect what we will be doing in **HB 1**.

Y. DAVIS: I know, but we haven't raised the spending cap.

CHISUM: I know, but we will before this bill leaves here. That will be in front of the house again tomorrow. There will be a supplemental bill; it's on tomorrow's calendar.

Y. DAVIS: I'm pleased that you're optimistic we're going to raise it. I hear what you're saying, but what if we don't, based on your going in front of the process like this. Doesn't it limit the ability to really, fully explore and deliberate on the issues the agencies bring before us so that we can meet the needs of folks out in various districts?

CHISUM: No, it doesn't, because we're going to have the same amount of revenue that we have if nothing else happens out there. The only issue is how we're going to fund this \$14 billion. That's the question we're going to answer in the next two days.

Y. DAVIS: My question is, if you take \$6 billion out of GR, you're telling me that won't impact what your ability is to do with the various agencies?

CHISUM: That is exactly right.

Y. DAVIS: Based on what?

CHISUM: Based on the fact we have a \$14 billion surplus.

Y. DAVIS: So your argument is, we have a \$14 billion surplus. Moving this money over will not impact your ability to meet the agencies' needs. Is that what you're saying?

CHISUM: That's exactly right. The reason is, when the SCR comes, it raises the spending limit so that we can only spend that 14 billion.

Y. DAVIS: Okay, but independent of raising the cap, do you have the ability to meet, or are you suggesting that you can meet all the needs to the state's agencies and all the needs of the communities without having a spending cap increase?

CHISUM: I'm here to tell you that once we do this—

Y. DAVIS: No, I'm saying that without the spending cap being busted, are you suggesting that you can meet all of the needs without having, and do this, without having to raise, to move the spending cap?

CHISUM: We cannot do that.

Y. DAVIS: Okay. So you predicated on us—

CHISUM: If we did that we would be \$8 billion over.

Y. DAVIS: Well, that's what I'm saying. So why are we going in front of having the appropriations process work, prior to taking this money out of GR? That's my point.

CHISUM: There's still the same amount available in GR that would still be within the cap. What we're doing is just raising the cap for enough to do the property tax relief. So that's all we're raising the cap. It does not affect how much the cap is out there right now, which is \$5.2 billion over the budget we're working on.

Y. DAVIS: But I want to be clear. We said during special session that we were raising enough money to cover property tax relief. You said today, no, in fact we didn't do it. What we put in place would not do that. Now you're saying that you can take money out for property tax relief and it won't have an impact on your ability to fund the things that people are coming for us. Yet you have agencies taking 10 percent cuts. At what point do they all come together?

CHISUM: They all come together once we get the SCR done.

Y. DAVIS: Once you raise the spending cap. So in fact, none of this fits unless you raise the spending cap. Is that correct?

CHISUM: No, that's not necessarily correct, because once we determined that we would not do that, then we have to go back into **HB 1**, even in the general bill, and we could reduce that eight billion by five billion that we have available to us, and then we would actually have to cut \$3 billion dollars out of **HB 1** that we've got in there right now.

Y. DAVIS: So aren't you premature, then? Why wouldn't you go through **HB 1** and meet the needs before you take out a chunk, so that you wouldn't have to go back?

CHISUM: This is a priority.

Y. DAVIS: So you decided you were going to do it this way, then tell us all we've got to bust the cap so we can meet the essential needs of the state? Is that so?

CHISUM: That is not correct. We have to do this or we're going to have to go into the essential needs of the state. And I have it all spelled out right down here for me. So if you want to come here and look at that. There will still be \$5 billion that we can go above the introduced version of **HB 1**.



**HB 2 - POINT OF ORDER**

Representative Burnam raised a point of order against further consideration of **HB 2** under Rule 4, Section 32(c) of the House Rules on the grounds that the bill analysis is incorrect.

The speaker overruled the point of order.

**Amendment No. 1**

Representative Leibowitz offered the following amendment to **HB 2**:

Amend **HB 2** at the end of SECTION 1 of the bill by adding the following new subsection:

( ) The amounts appropriated by Subsections (a)(1)(B) and (a)(2)(B) of this section are contingent on the approval of **HJR 65** or a similar measure by the 80th Legislature, Regular Session, 2007, proposing a constitutional amendment increasing the amount of the residence homestead exemption from ad valorem taxation for public school purposes to not less than \$45,000 in order to provide further school property tax relief to local taxpayers. If the 80th Legislature, Regular Session, 2007, does not approve **HJR 65** or a similar measure proposing a constitutional amendment increasing the amount of the residence homestead exemption from ad valorem taxation for public school purposes to not less than \$45,000, the appropriations provided by Subsections (a)(1)(B) and (a)(2)(B) of this section have no effect.

Representative Chisum moved to table Amendment No. 1.

**STATEMENT BY SPEAKER CRADDICK REGARDING  
PARLIAMENTARY INQUIRY BY REPRESENTATIVE HOCHBERG**

The speaker had read the following statement:

Mr. Hochberg asked a question regarding **HB 2**. Specifically, he asked whether **HB 2** was part of the LBB's initial budget recommendations. **HB 2** was not part of the LBB's initial budget recommendations. The LBB's budget recommendation is contained in **HB 1** and **SB 1**.

Mr. Hochberg also asked how the LBB laid out **HB 1** without having the fund proposed in **HB 2**. Limitations on the LBB's ability to lay out a budget are contained in Chapter 316, Government Code. Chapter 316 contains a number of provisions relating to setting the initial budget items under the general provisions of Chapter 316. The total amount of increased spending is based on the estimated rate of growth of the state's economy. The budget presented by the LBB fell within the estimated rate of growth of the state's economy. These recommendations were forwarded to the legislature within the prescribed limits.

If the question is could the LBB have adopted a higher spending limit, the answer is Chapter 316 allows a different economic model to be substituted for the estimated rate of growth limitation. No such alternative model was presented. Additionally, a higher rate may be adopted by committee, described in Chapter 316. Finally, members of the legislature may also raise the proposed limits on appropriations.

### REASONS FOR VOTE

Last year I entered a statement in the House Journal regarding **CSHB 1** that stated my concern that the bill, "will likely require much of the available revenue in the next biennium and in the future to pay for property tax cuts. This could threaten the Legislature's ability to fund education, health care, transportation, public safety and other pressing state needs in the future." Unfortunately, this prediction has come to pass less than a year later.

Before the revised franchise tax has even been implemented, even before this year's budget has been passed, the Legislature is being asked to take \$6 billion in general revenue to pay for the property tax cuts implemented last year. As a result, those other priorities of the state like education, health care, transportation and public safety are being forced to take a back seat to property tax cuts like I foresaw last year.

Although I am a strong supporter of cutting property taxes, I believe the funding of the property tax cut should have taken place during the budget debate. The budget debate allows members to weigh priorities side-by-side and then cast votes for spending priorities they feel are the most important to the welfare of this state. **HB 2** sets property tax cuts as a special priority above all others. No one is a stronger supporter of property tax reduction than myself, but property tax reductions should be debated alongside education and health care, not put in a separate category exempt from discussion and considered in a vacuum. I am

voting for **HB 2** to provide property tax relief for my constituents, but I wish that issues addressed in this bill were debated at the same time as the rest of the budget.
