**HB 2859 - REMARKS**

REPRESENTATIVE MARTINEZ FISCHER: Ms. Brown, would you mind postponing this bill to a time certain, being the local and consent calendar Friday at 9 a.m.?

REPRESENTATIVE B. BROWN: I would like to know why.

MARTINEZ FISCHER: We would like to make sure that all bills that have been set on the local and consent calendar on Friday get passed.

B. BROWN: Alright, but I would just like to make you aware of the background of this bill. And if for some reason this bill doesn't get passed, you will owe an apology to a grieving family who brought me this bill. Their 16-year-old daughter was killed by a drunk driver. They testified in the committee meeting and the committee was so moved that they elected to vote at that time to move this bill to local and consent. It was their wishes that it be passed very quickly. The family had gone through so much before. I was hoping that they would be here today, and I could introduce them from the gallery, so that you could look them in the face and say that because I want to throw a tantrum on the floor. I am going to cost you your bill that they had worked two years on bringing.

MARTINEZ FISCHER: I don't believe there is a tantrum being thrown on this floor. And I believe as apologies are concerned, there are lots of apologies—

#### **STATEMENT BY REPRESENTATIVE MARTINEZ FISCHER**

Ms. Brown has asked that the statements between she and I be reduced to writing and placed in the journal. The conversation was one-sided and I feel it appropriate to respond more fully. Let me be very clear, I asked Ms. Brown to postpone her bill to preserve the sanctity of future local and consent calendars and the safe passage of her bill. It was Ms. Brown that chose not to extend a courtesy to a fellow member by allowing postponement—a courtesy that all members extend to their colleagues. The bill's fate rests in her hands and on her conscience no matter her protestations.

Bills by myself and my colleagues that have been fully investigated by bipartisan committees and given unanimous consent are languishing in the Local and Consent Calendars Committee with no hope of being heard. All the while, hundreds of bills by members loyal to the leadership have been passed without having to wait. If the local and consent calendar becomes infected with partisan zealotry and unfairness, then every part of the legislative process carries that stain. If there is an apology owed to anyone, it is owed by the members of the Local and Consent Calendars Committee to the millions of Texans whose elected representatives have not been given the privilege of a fair hearing on the floor.
