HB 3544 - STATEMENT OF LEGISLATIVE INTENT

REPRESENTATIVE KENT: Representative Lucio, you and I have spoken before today, and I'd like to ask a question of you regarding Section 5.128, Subsection 5. Could you tell me what it means with regard to providing the governmental body by a person of purpose for providing public comment and receiving notices, orders, and decisions from a governmental body? In what senses will that information be defined?

REPRESENTATIVE LUCIO: For instance, all public comment is already subject to open records requests. So when someone goes and registers their name and information and e-mail when they make public comment, that's already subject to open records. What we want to protect is those who just want to receive information they would receive otherwise via hardcopy through e-mail,

and those e-mails will be protected and kept confidential and not subject to open records requests. But any other interaction with the agency not related to the parameters of this bill, whether it's public comment, whether it's "I'm a vendor and I do work with the agency," or whether it's any information that I submit to the agency in the normal course of public interaction with the agency, those will, as they already are, be subject to open records.

KENT: And that would be including hearings where people come to sign in and give their e-mail at that point?

LUCIO: That's correct.

KENT: What about e-mails that come to my office personally as a state representative of somebody asking for information? Would those e-mails be public information?

LUCIO: No, and those e-mails would be not subject to public information because of the confidentiality that you have, as your office, between your interaction with the agency, and any information you communicate is usually kept confidential.

On annexation of an area of the Authority for full purposes by a municipality, the Authority's power to regulate the area under Chapters 211 or 212 expires. The Authority regains the power in an area if the municipality disannexes the area"
