Both of those are wholly in Fannin County, so they have no impact in your county, his county, their counties around. This is a local bill.

D. MILLER: So it's your opinion, then, that this is a local bill.

PHILLIPS: For legislative intent, this affects only local reservoirs in Fannin County.

D. MILLER: Thank you, Representative Phillips, and I congratulate you on bringing this bill.

HARTNETT: Correct.

WEBER: Is it fair to assume that most all of the process servers would have the same opportunity to get certified by the supreme court if they so chose to do so?

HARTNETT: Yes.

WEBER: Okay, and just for reclarification, you're not attempting to somehow ratify the existence of the board.
