#### FIRST DAY — MONDAY, JULY 1, 2013

In obedience of the proclamation of His Excellency, Rick Perry, Governor of the State of Texas, convening the 83rd Legislature, Second Called Session, to meet in special session at Austin, Texas, the seat of government, on this the first day of July 2013, the members of the House of Representatives assembled in the hall of the House of Representatives, and at 2 p.m., at the request of the speaker, the house was called to order by the Honorable Linda Harper-Brown.

The chair recognized Representative Flynn who introduced John Robinson, pastor, Assembly of Yahvah, Emory, who offered the invocation as follows:

Help us to remember that our words spoken here today will reverberate throughout eternity.

We know that there is a time to weep and a time to rejoice. Help us to sow tears of sorrow today so we can rejoice tomorrow. Open our ears so that we can hear your wisdom crying in the streets. Open our eyes so that we can see your truth that seems to be hidden in plain view, right before us. Please help us as individuals to seek harmony and unity with you and then allow you to work out the other details.

I thank you for the representatives that we have here today from all over our state, but today, I ask you for someone to represent you. Please send us your duly elected representative. We need a representative who knows you and loves you enough to plead for justice on your behalf. We need leaders who have learned to follow you. And when you send them, please help us to recognize them for who they are and to give them a cup of cool water instead of ridiculing or opposing them like we have done in the past. Help us to get our eyes off of ourselves and to be more concerned about our righteousness than our rights.

Yahvah, I thank you that your children need not be discouraged or dismayed. It's good to know that your servants don't need to be frustrated or worried about the dark storm clouds on the horizon because you have heard our prayers and help is on the way and truth will prevail. Thank you most of all for the sacrifice of your son, Yahshua, by whose death we are justified and by whose life we can be saved.

The chair recognized Representative Flynn who led the house in the pledges of allegiance to the United States and Texas flags.

## PROCLAMATION BY THE GOVERNOR OF THE STATE OF TEXAS

The chair laid before the house and had read the following proclamation by the governor:

#### TO ALL WHOM THESE PRESENTS SHALL COME:

I, RICK PERRY, GOVERNOR OF THE STATE OF TEXAS, by the authority vested in me by Article III, Section 5 and Article IV, Section 8 of the Texas Constitution, do hereby call an extraordinary session of the 83rd Legislature, to convene in the city of Austin, commencing at 2 p.m. on Monday, July 1, 2013, for the following purposes:

To consider legislation relating to the regulation of abortion procedures, providers, and facilities.

To consider legislation relating to the funding of transportation infrastructure projects.

To consider legislation relating to establishing a mandatory sentence of life with parole for a capital felony committed by a 17-year-old offender.

The secretary of state will take notice of this action and will notify the members of the legislature of my action.

#### PARLIAMENTARY INQUIRY

REPRESENTATIVE C. TURNER: Madam Speaker, I had a parliamentary inquiry. Is it possible to still make the inquiry?

CHAIR (Harper-Brown in the chair): Yes, state your inquiry.

C. TURNER: Do the rules of the house that we adopted at the beginning of the regular session permit committees to hold public hearings on legislation outside of Austin?

CHAIR: Yes, in fact the committees held redistricting hearings throughout the state.

C. TURNER: Right, I recall that. So we do have a practice of committees holding committee hearings. Speaking of redistricting, Madam Speaker, is it fair to say that the redistricting legislation involves rights guaranteed by the constitution and the federal Voting Rights Act?

CHAIR: You will have to ask Mr. Darby about why he held meetings throughout the state.

C. TURNER: Okay. I think it's commonly accepted that redistricting does involve constitutional rights. So, parliamentary inquiry, Madam Speaker.

CHAIR: State your inquiry.

C. TURNER: Since we have some precedent in recent history of holding hearings when legislation affects a great number of people and involves constitutional rights, there is some precedent for holding public hearings, and my question is, does it require a vote of the body, a vote of the house, to authorize public hearings by committees outside of Austin? Or may the committee chair schedule those hearings at his or her discretion?

CHAIR: I will let you take that up with the committee chair.

C. TURNER: So it's at the chair's discretion?

CHAIR: If you would, take that up with the committee chairman.

C. TURNER: Okay, so if members wish to suggest to a committee chairman, if he or she is hearing a bill that impacts peoples' constitutional rights across the State of Texas, it would be appropriate then for members to approach that committee chair and suggest a series of field hearings?

CHAIR: The good news is, Mr. Turner, that the members of the Texas House have never been shy about asking the chairman for certain actions.

C. TURNER: I would agree with that, Madam Speaker, thank you.
