knowingly or recklessly sells a motor vehicle in which an airbag is not installed without clearly disclosing that the vehicle does not have an airbag; or

(3) In Section 547.614(a-2)(4), Transportation Code, (page 1, line 18), strike "(1), (2), or (3)" and substitute "(1), (2), ~~or~~ (3), or (4)".

(4) In Section 547.614(a-2)(4), Transportation Code, (page 1, line 19), strike "(1), (2), or (3)" and substitute "(1), (2), ~~or~~ (3), or (4)".
