**CSSB 748** (Geren - House Sponsor), A bill to be entitled An Act relating to the use of certain tax revenue to enhance and upgrade convention center facilities, multipurpose arenas, venues, and related infrastructure in certain municipalities.

**CSSB 820** (Guillen - House Sponsor), A bill to be entitled An Act relating to the management, breeding, and destruction of deer and to procedures regarding certain deer permits.

**SB 852** (Smithee - House Sponsor), A bill to be entitled An Act relating to availability of certain property and casualty insurance forms.

**SB 905** (Kuempel - House Sponsor), A bill to be entitled An Act relating to the sale of distilled spirits to ultimate consumers by the holder of a distiller's and rectifier's permit.

**CSHB 138** (by Raymond), A bill to be entitled An Act relating to funding for certain commercial service airport projects. (Anderson, Flynn, Krause, Schaefer, Simpson, Stickland, and Zedler recorded voting no.)

**SB 902** (Callegari - House Sponsor), in lieu of **HB 168**, A bill to be entitled An Act relating to the operation, powers, and duties of certain water districts.

**HB 693** (by Phillips), A bill to be entitled An Act relating to the authority of a water and sewer utility to collect voluntary contributions on behalf of a local library. (Krause and Stickland recorded voting no.)

**CSHB 746** (by Ashby), A bill to be entitled An Act relating to the registration of volunteer health practitioners and the services of volunteer health practitioners during disasters.

**CSHB 796** (by S. Thompson), A bill to be entitled An Act relating to the regulation of electrical contracting, including the licensing of a journeyman lineman. (Anderson, Burkett, Capriglione, Flynn, Krause, Lavender, Perry, Phillips, Sanford, Schaefer, Simpson, Stickland, and Zedler recorded voting no.) **SB 458** (Márquez - House Sponsor), in lieu of **HB 987**, A bill to be entitled An Act relating to certain motor vehicle records excepted from disclosure under the Public Information Act.

Representative Márquez moved to lay **HB 987** on the table subject to call, and the motion prevailed.

**CSHB 1018** (by Patrick, Kolkhorst, et al.), A bill to be entitled An Act relating to the establishment of community partnerships and the development of policy recommendations for increasing physical activity and improving fitness among public school students. (Capriglione, Phillips, Sanford, Schaefer, and Simpson recorded voting no.)

**CSHB 1020** (by Reynolds), A bill to be entitled An Act relating to the certification of alcohol awareness programs required for minors convicted of or receiving deferred disposition for certain alcohol offenses.

**HB 1044** (by Eiland), A bill to be entitled An Act relating to the operation of all-terrain vehicles and recreational off-highway vehicles; creating an offense. (Anderson, Capriglione, Flynn, Krause, Sanford, Schaefer, Simpson, Stickland, and Zedler recorded voting no.)

**SB 506** (S. Thompson - House Sponsor), in lieu of **HB 1184**, A bill to be entitled An Act relating to an exemption from registration and regulation requirements for steam cookers.

Representative S. Thompson moved to lay **HB 1184** on the table subject to call, and the motion prevailed.

**HB 1185** (by S. Thompson and Longoria), A bill to be entitled An Act relating to the retention of certain records in a suit affecting the parent-child relationship by a child's attorney ad litem, guardian ad litem, or amicus attorney. (Krause, Schaefer, and Springer recorded voting no.)

**CSHB 1198** (by Raymond, et al.), A bill to be entitled An Act relating to authorizing an optional county fee for vehicle registration in certain counties. (Krause, Stickland, Taylor, and E. S. Turner recorded voting no.) (Carter requested to be recorded voting no after the deadline established by Rule 5, Section 52 of the House Rules.)

**CSSB 365** (Parker - House Sponsor), in lieu of **HB 1203**, A bill to be entitled An Act relating to expedited credentialing for certain podiatrists and therapeutic optometrists providing services under a managed care plan.

Representative Parker moved to lay **HB 1203** on the table subject to call, and the motion prevailed.

**CSSB 611** (Lucio - House Sponsor), in lieu of **HB 1214**, A bill to be entitled An Act relating to the irrigation powers and functions of certain water districts; providing authority for a district by rule to change fees; clarifying a district's authority to impose certain assessments.

#### Amendment No. 1

Representative Geren offered the following amendment to CSSB 611:

Amend CSSB 611 (house committee report) as follows:

(1) On page \_\_\_\_\_, line \_\_\_\_\_, insert the following:

Sec. 51.091. PROJECTS OF CERTAIN DISTRICTS. (a) In this section "preservation district" means a district defined by Chapter 54 and created by special law with the power to promote the preservation of fish and other wildlife within its boundaries.

(b) A water supply project financed, in whole or in part, with water development bonds as defined under Section 16.001, that is undertaken by a district having operations or facilities located in not less than 4 counties, and that is included in a regional water plan under Section 16.053, is of fundamental and paramount importance and is to be given priority over the activities, rules, regulations, ordinances, or any requirement for a permit, bond, or fee of a preservation district, which shall be inapplicable to the construction of the project.

(c) Governmental immunity of a preservation district is waived in an action brought by a district described in subsection (b) for the acquisition of land, easements or other property for a project described in subsection (b), if the preservation district is the owner of the land or property.

(d) Notwithstanding any other law, venue shall lie in Travis County for an action described in subsection (c) and brought by a district described in subsection (b).

(e) This section expires September 1, 2039.

Amendment No. 1 was adopted.

**CSHB 1249** (by Nevárez, Menéndez, Farias, et al.), A bill to be entitled An Act relating to the designation of portions of State Highway 17 and United States Highway 67 as the General Alfred Valenzuela Highway. (Springer recorded voting no.)

**HB 1354** (by Farney), A bill to be entitled An Act relating to the creation of the Leander Hills Municipal Utility District of Williamson County; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes.

**HB 1355** (by Farney), A bill to be entitled An Act relating to the creation of the North San Gabriel Municipal Utility District of Williamson County; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes.

(d) After September 1, 2023, the district, at the district's expense, shall repair and maintain any streets in the district.

(e) The district's repair and maintenance of a street under this section must comply with all applicable construction standards and regulations of Williamson County.

(5) On page 6, between lines 12 and 13, insert the following:

Sec. 8432.106. NO EMINENT DOMAIN POWER. The district may not exercise the power of eminent domain.

(6) On page 22, strike lines 3-11.

(7) On page 22, line 12, strike "SECTION 5" and substitute "SECTION 4".

Amendment No. 1 was adopted.

**CSHB 1454** (by N. Gonzalez), A bill to be entitled An Act relating to events to educate students about Type 2 diabetes in certain school districts. (Krause, Schaefer, Simpson, and Stickland recorded voting no.)

**CSHB 1458** (by Gooden), A bill to be entitled An Act relating to the designation of U.S. Highway 175 in Kaufman County as the Veterans Memorial Highway.

Representative Callegari moved to lay **HB 1547** on the table subject to call, and the motion prevailed.

**HB 1563** (by T. King), A bill to be entitled An Act relating to fees of office for directors of groundwater conservation districts. (Anderson, Capriglione, Flynn, Schaefer, Simpson, and Zedler recorded voting no.)

**HB 1586** (by Creighton), A bill to be entitled An Act relating to municipal consent provisions applicable to the Montgomery County Municipal Utility District No. 126.

**HB 1593** (by Huberty), A bill to be entitled An Act relating to the powers and duties of the Harris County Municipal Utility District No. 505; providing authority to issue bonds; providing authority to impose fees and taxes.

**HB 1594** (by Huberty), A bill to be entitled An Act relating to the powers and duties of the Harris County Municipal Utility District No. 504; providing authority to issue bonds; providing authority to impose fees and taxes. (Taylor recorded voting no.) (Carter requested to be recorded voting no after the deadline established by Rule 5, Section 52 of the House Rules.)

**HB 1632** (by Fletcher), A bill to be entitled An Act relating to certain identifying information of peace officers, county jailers, security officers, and employees of the Texas Department of Criminal Justice or a prosecutor's office excepted from disclosure under the Public Information Act.

#### Amendment No. 1

Representative Fletcher offered the following amendment to HB 1632:

Amend HB 1632 (house committee report) as follows:

(1) On page 1, line 14, strike "Section 552.1175(b), Government Code, is" and substitute "Sections 552.1175(b) and (e), Government Code, are".

(2) On page 2, between lines 2 and 3, insert the following:

(c) All documents filed with a county clerk and all documents filed with a district clerk are exempt from this section, except that the county clerk or district clerk may redact the street address of an individual to whom this section applies from a document filed with the clerk without the necessity of requesting a decision from the attorney general under Subchapter G at the request of the individual, if that individual identifies to the clerk the specific document containing the address.

(C) unable to make a rational and informed decision as to whether to submit to treatment.

SECTION 2. Section 573.001(b), Health and Safety Code, is amended to read as follows:

(b) A substantial risk of serious harm to the person or others under Subsection (a)(1)(B) may be demonstrated by:

(1) the person's behavior; or

(2) evidence of the person being gravely disabled [severe emotional distress and deterioration in the person's mental condition] to the extent that the person cannot remain at liberty.

SECTION 3. Section 573.003(b), Health and Safety Code, is amended to read as follows:

(b) A substantial risk of serious harm to the ward or others under Subsection (a)(2) may be demonstrated by:

(1) the ward's behavior; or

(2) evidence of the ward being gravely disabled [severe emotional distress and deterioration in the ward's mental condition] to the extent that the ward cannot remain at liberty.

SECTION 4. Section 573.012(c), Health and Safety Code, is amended to read as follows:

(c) A substantial risk of serious harm to the person or others under Subsection (b)(2) may be demonstrated by:

(1) the person's behavior; or

(2) evidence of the person being gravely disabled [severe emotional distress and deterioration in the person's mental condition] to the extent that the person cannot remain at liberty.

SECTION 5. Section 573.022(a), Health and Safety Code, is amended to read as follows:

(a) A person may be admitted to a facility for emergency detention only if the physician who conducted the preliminary examination of the person makes a written statement that:

(1) is acceptable to the facility;

(2) states that after a preliminary examination it is the physician's opinion that:

(A) the person is mentally ill;

(B) the person evidences a substantial risk of serious harm to himself or others;

(C) the described risk of harm is imminent unless the person is immediately restrained; and

(D) emergency detention is the least restrictive means by which the necessary restraint may be accomplished; and

(3) includes:

(A) a description of the nature of the person's mental illness;

(B) a specific description of the risk of harm the person evidences that may be demonstrated either by the person's behavior or by evidence of the person being gravely disabled [severe emotional distress and deterioration in the person's mental condition] to the extent that the person cannot remain at liberty; and

(C) the specific detailed information from which the physician formed the opinion in Subdivision (2).

SECTION 6. Section 574.011(d), Health and Safety Code, is amended to read as follows:

(d) If the certificate is offered in support of a motion for a protective custody order, the certificate must also include the examining physician's opinion that the examined person presents a substantial risk of serious harm to himself or others if not immediately restrained. The harm may be demonstrated by the examined person's behavior or by evidence of the person being gravely disabled [severe emotional distress and deterioration in the examined person's mental condition] to the extent that the examined person cannot remain at liberty.

SECTION 7. Section 574.022(b), Health and Safety Code, is amended to read as follows:

(b) The determination that the proposed patient presents a substantial risk of serious harm may be demonstrated by the proposed patient's behavior or by evidence of the person being gravely disabled [severe emotional distress and deterioration in the proposed patient's mental condition] to the extent that the proposed patient cannot remain at liberty.

SECTION 8. Sections 574.034(a) and (d), Health and Safety Code, are amended to read as follows:

(a) The judge may order a proposed patient to receive court-ordered temporary inpatient mental health services only if the judge or jury finds, from clear and convincing evidence, that:

- (1) the proposed patient is mentally ill; and
- (2) as a result of that mental illness the proposed patient:
  - (A) is likely to cause serious harm to himself;
  - (B) is likely to cause serious harm to others; or
  - (C) is gravely disabled [:

[(i) suffering severe and abnormal mental, emotional, or physical distress;

[(ii) experiencing substantial mental or physical deterioration of the proposed patient's ability to function independently, which is exhibited by the proposed patient's inability, except for reasons of indigence, to provide for the proposed patient's basic needs, including food, clothing, health, or safety; and

[(iii) unable to make a rational and informed decision as to whether or not to submit to treatment].

(d) To be clear and convincing under Subsection (a), the evidence must include expert testimony and, unless waived, evidence of a recent overt act or a continuing pattern of behavior that tends to confirm:

(1) the likelihood of serious harm to the proposed patient or others; or

(2) the proposed <u>patient being gravely disabled</u> [<del>patient's distress and</del> the deterioration of the proposed patient's ability to function</del>].

SECTION 9. Sections 574.035(a) and (e), Health and Safety Code, are amended to read as follows:

(a) The judge may order a proposed patient to receive court-ordered extended inpatient mental health services only if the jury, or the judge if the right to a jury is waived, finds, from clear and convincing evidence, that:

(1) the proposed patient is mentally ill;

- (2) as a result of that mental illness the proposed patient:
  - (A) is likely to cause serious harm to himself;
  - (B) is likely to cause serious harm to others; or
  - (C) is gravely disabled [:

[(i) suffering severe and abnormal mental, emotional, or physical distress;

[(ii) experiencing substantial mental or physical deterioration of the proposed patient's ability to function independently, which is exhibited by the proposed patient's inability, except for reasons of indigence, to provide for the proposed patient's basic needs, including food, clothing, health, or safety; and

[(iii) unable to make a rational and informed decision as to whether or not to submit to treatment];

(3) the proposed patient's condition is expected to continue for more than 90 days; and

(4) the proposed patient has received court-ordered inpatient mental health services under this subtitle or under Chapter 46B, Code of Criminal Procedure, for at least 60 consecutive days during the preceding 12 months.

(e) To be clear and convincing under Subsection (a), the evidence must include expert testimony and evidence of a recent overt act or a continuing pattern of behavior that tends to confirm:

(1) the likelihood of serious harm to the proposed patient or others; or

(2) the proposed patient being gravely disabled [patient's distress and the deterioration of the proposed patient's ability to function].

SECTION 10. This Act takes effect September 1, 2013.

REPRESENTATIVE KLEINSCHMIDT: Representative Farrar, I am curious about this bill. It is creating attorney's fees for events for dealing with cruelty to animals, is that correct?

REPRESENTATIVE FARRAR: It allows—this was brought to me by Harris County—and it allows Harris County, well, and other counties too, to be able to recoup attorney's fees so that they will go after more of these cases, because they can't afford to.

KLEINSCHMIDT: Well, I'm curious—in human assault cases, I'm not aware that we can even recover attorney's fees if a human assaults a human, that their attorney's fees can be recovered, yet you are providing statutorily for attorney's fees to be recovered if there is, essentially, an assault on an animal or cruelty to animals charge?

FARRAR: Well, animals are property, and so I can't speak—this is a totally different area of the law, so, I can't speak to that.

KLEINSCHMIDT: But you are creating a new set of attorney's fees for this particular action?

FARRAR: We're allowing them to find a source of revenue so that they can go after these cases, because they are very important, because these offenders typically will graduate to hurt humans. And, so, we want to stop that.

KLEINSCHMIDT: But you understand my worry here? My worry here-

FARRAR: I understand, yes.

KLEINSCHMIDT: Is it your intent to elevate an action involving a damage to an animal; is it your intent to elevate that above an injury to a human?

FARRAR: Absolutely not. That wasn't even considered when the county brought me this bill.

KLEINSCHMIDT: Okay, so-

FARRAR: I understand your concern, but that's not a part of this.

KLEINSCHMIDT: That's not your intent?

FARRAR: Absolutely not.
