**SB 201 - STATEMENT OF LEGISLATIVE INTENT**

REPRESENTATIVE HOWARD: I just have a few questions that I wanted to ask you about something we discussed earlier. We spoke yesterday regarding some of my constituents' concerns about the accessibility of the Capitol for the visually impaired, is that not correct?

REPRESENTATIVE PRICE: That's correct.

HOWARD: And I mentioned to you that the offices here, in both the Capitol and the extension, currently have Braille that lists the room number but do not have Braille under the members' names, which makes it difficult to navigate for some of the visually impaired visitors to our Capitol. Is that not correct?

PRICE: That's what I understand, yes.

HOWARD: And based on a conversation that you and I had with John Sneed, the State Preservation Board has already initiated an effort to look at addressing this, and they will offer some effective and cost-efficient options by the end of 2013, is what he conveyed to us. Is that not correct?

PRICE: That's correct. He gave a copy of a letter that he addressed to you to me this morning, and it indicated that they've already begun an investigation into the issues to determine what cost-efficient options might be available. And I think John Sneed is doing a really good job being responsive to these issues. I think it's an important issue, and I understand that they will have timely options for your office to consider, and ours and others, as well.

HOWARD: Well, I appreciate you taking the time to discuss this with me. I appreciate Mr. Sneed and the work that they're already doing.

#### **SB 15 ON THIRD READING (Branch - House Sponsor)**

**SB 15**, A bill to be entitled An Act relating to the governance of public institutions of higher education in this state.

#### **Amendment No. 1**

Representative Branch offered the following amendment to **SB 15**:

Amend **SB 15** on third reading as follows:

(1) Strike the introductory clause to SECTION 1 of the bill and substitute the following:

Section 51.352, Education Code, is amended by amending Subsections (a), (b), (d), and (e) and adding Subsections (a-1), (a-2), (a-3), (a-4), and (a-5) to read as follows:

(2) In SECTION 1 of the bill, in added Section 51.352(a-4), Education Code, as substituted by Floor Amendment No. 2 by Branch, strike "or by the university system office if the member serves on the governing board of a university system" and substitute "by the system office of a university system, or by the office of a governing board that does not govern a university system".

(3) In SECTION 1 of the bill, strike added Section 51.352(a-6), Education Code, as substituted by Floor Amendment No. 2 by Branch.

(4) In SECTION 1 of the bill, in amended Section 51.352(d)(1), Education Code, between "and" and "consulting", insert "if applicable the chancellor of the university system and after".

(5) In the SECTION of the bill amending Section 111.12, Education Code, as added by Floor Amendment No. 1 by Branch, strike the last sentence of Subsection (b) of that section and substitute the following: "To implement the change in law made by this section to Section 111.12, Education Code, the terms of office of members of the board that begin in 2013 expire on February 1, 2019, the terms of office of members of the board that begin in 2017 expire on February 1, 2021, and the terms of office of members of the board that begin in 2017 expire on February 1, 2023.

Amendment No. 1 was adopted.

**REASON FOR VOTE**

Over my years of service, I always side with transparency for Texas taxpayers, voters, and citizens. REPRESENTATIVE SIMMONS: Representative Anchia, first of all, I want you to know that I support the bill. No question about it. As vice-chairman of the Autism Society of America, the federal program and the state programs around this country are a big part of the donations that come to that, so I support it. I am concerned—and I do agree with you that—it may not be the legislative body, but would you agree with me that we, as legislators, have maybe not the obligation, but certainly the right to contact the people that are in charge of this program, as well as the governor—lieutenant governor's office—to make sure that there are not organizations on here that we believe are outside of statute or outside of what we agree with.

REPRESENTATIVE ANCHIA: I think that's right. Listen, there's a statute that says it should go to Health and Human Services. I am not privy to the list of what state employees want to give to, but there are criteria for being on the list,

and once that is achieved it is still subject to the discretion of the state commission that is appointed by the governor, the lieutenant governor, and the comptroller.

SIMMONS: They should follow the statute because, for example, I do know for a fact that PETA is listed as one of the organizations—and that may be a fine organization for people to give to, but it's not part of Health and Human Services. So what we would need to do is contact this commission and let them know that, "hey, we want to make sure you're following the statute, and here are some that we believe lie outside of that." Is that correct?

ANCHIA: I think that's—if, in fact, PETA is on the list—I have not seen—

SIMMONS: You just go to the website and look them up. It's pretty easy to do.

ANCHIA: I have not seen the list, but if, in fact, they are as you are representing to us today—you at least want the comptroller, governor, and lieutenant governor's appointees to justify how that is Health and Human Services if, in fact, they have that perception. You'd want them to document that and explain it to you as a lawmaker.

SIMMONS: For legislative intent purposes, it is our intent of this bill that this could be continued, but also that it be continued within the statutes that exist today. Is that correct?
