Alongside of the Lord Jesus, our character and our conduct are all that we have. To him, this is not politics as usual, nor position or power. Help us, we pray, so that we would be like Jesus so we should not be ashamed nor bring sadness to your heart.

Father, from the scriptures and from life, we have learned the truth that the greatest of all sins is to be conscious of none. We confess that we fall short in many, many ways. We are broken people; we have issues. Sometimes even our issues have issues. This side of heaven, we'll never be perfect, but with your grace and mercy, we can be blameless by walking in truth, by trusting in you, and by looking to Jesus as our guide for wisdom and goodness.

Father, we praise you this afternoon for one of your greatest and unique gifts in Jesus, that gift of beginning again and having the opportunity to start over. Because of Jesus' sacrifice on the cross, as Christ-followers we can be forgiven and cleansed from mistakes and misdeeds, from faults and failures, from wrongs and offenses. Jesus delivers us from guilt, frees from the past, and gives us a new day and a fresh start. We thank you that in Jesus there is genuine redemption, in Jesus leopards do change their spots, lives are transformed, people are changed, we are given a second chance, an incredible opportunity to be a new and different person.

I pray this afternoon, Father, the simple prayer of a child: Please, God, make all the bad people good, and make all the good people kind. With all our hearts and minds and souls, we pray that you would bless Texas and that you would bless America. In Jesus' name, we pray. Amen.
