#### HR 761 - REMARKS

REPRESENTATIVE ZERWAS: This is a unique opportunity that I have, and it's one that is very personal to me and very personal to many members of this body. Many of you will be getting this brochure today, "What Cancer Means to Me," and several of you all are actually featured in this, including myself, recognizing my parents and my late wife, who you all were very helpful to me during the last legislative session. If you have had cancer affect you, your family, friends—dear friends that I'm surrounded here by others who have had similarly, Jason Villalba gave a very moving testimony of his sister's encounter with lung cancer, I believe, and a very moving testimony to that.

But if you have in fact been affected by cancer, please come join me up here at the podium. Some of us have been affected personally, some of us have had family members. It goes without saying that cancer is a disease that has touched many, many of us in one way or another, and I doubt there is anybody that hasn't witnessed a life cut short by cancer, whether it's a family member, whether it's a friend, or another acquaintance. I know that I certainly have had that experience, and the support of this body and the friendship that you all loaned to me during that time when my wife was struggling with glioblastoma was something that I don't think that, frankly, I could have weathered that storm without the support and prayers that you all offered. Cancer continues to be a formidable challenge to the medical profession. The good news is that we are making progress every day with new advances, and we have to keep up that fight. I know Chairman Keffer in his leadership, and this body, with regard to the Cancer Prevention Research Institute of Texas, have been a very, very big part of that, and the opportunity that we in Texas have to continue this battle against cancer is better than any other state in this nation.

I'm pleased to recognize today volunteers from the American Cancer Society Cancer Action Network, who are here today for their day at the Capitol. Among these volunteers are cancer survivors, caregivers, medical professionals, and many others. Approximately 150 Texans from around the state are here today to share their cancer stories and inform us on ways that public policy can help advance the fight against cancer in Texas. In honor of the work of these volunteers and others across the state, the resolution that has just been read has been offered up. Mr. Speaker, before I move for passage of this resolution, I'd like to recognize a couple of my members. I would like to yield the podium to a couple of members of this body who can speak to their personal encounters.

I will share with you mine, and most of y'all, I see, remember it well. It was just two years ago that I was standing at this podium with all of you all around me, and my wife was sitting up in the gallery. At that point, she couldn't walk, she couldn't talk, but she was there. So many of y'all and so many of your spouses took her under your wing and helped her enjoy the entirety of the legislative session, which to us was actually one of the high points of our life and of our marriage, and something we just absolutely enjoyed doing together. That's where she wanted to spend the last months of her life, here among the friends we had developed in the Texas Legislature. It is probably the greatest dividend that we all enjoy from this very strenuous public service, is that friendship that we have together. I will tell you, those prayers lifted me, they lifted her, they lifted my entire family; and those prayers are going to continue to kind of energize the people who are here to advocate on behalf of cancer and to make Texas the leader in curing cancer. I know there are others with us here that would like the opportunity to share their story, but I will tell you, my family was extended enormously by virtue of being here with you all during what ended up being, no doubt, the most trying and difficult time in my life, and it wouldn't have been as good of an opportunity, as I had to deal with that, if it were not for you. I thank you all for being such great advocates for cancer and for being a great friend to me.

REPRESENTATIVE S. DAVIS: I am 38 years old. I was diagnosed with breast cancer at the age of 32. I spent an entire year fighting it—chemotherapy, radiation, surgeries, bald, no eyebrows, no eyelashes. It was one of the hardest years of my life. I have no history of breast cancer in my family, and I am negative for the gene for breast cancer. I share these facts with you because my message about cancer is that it does not discriminate. Cancer doesn't care how old you are, it doesn't care what religion you practice, it doesn't care what your race is. We are all vulnerable. So I am so grateful to the American Cancer Society and all the volunteers for everything that they do to help find cures for these most dreaded diseases that each and every one of us will face, either personally or within their own family. And the last thing I want to say is that CPRIT has been one of the most important things that Texas has created in terms of fighting cancer. There is literally a brain drain in this country. We have all of the best and the brightest researchers and physicians here in Texas, and there is always a dialogue every session about continuing the funding for CPRIT. But I can tell you that the nation watches Texas, and what we do with CPRIT will affect Texas and how we deal with cancer for generations to come. So I just hope that you all will pause when you have to make decisions about CPRIT, and look over at me and try to imagine in your mind me bald and without eyebrows, and say, maybe we need to remain the leader in cancer research.
