HB 2488 (By Smithee), Relating to the limitation on the amount of supplemental payments under the Texas Economic Development Act.

HB 2490 (By Burns), Relating to the regulation of certain amusement rides by the Texas Department of Licensing and Regulation; requiring an occupational license.

HJR 100 (By Sheets), Proposing a constitutional amendment authorizing the governing body of a political subdivision to adopt a local option exemption from ad valorem taxation of a portion, expressed as a dollar amount, of the market value of real property of a business that employs honorably discharged veterans.
