# CSHB 11 - (consideration continued) CSHB 11 - POINT OF ORDER

Representative Simpson raised a point of order against further consideration of **CSHB 11** under Rule 8, Section 3 of the House Rules on the grounds that it violates the one-subject rule.

The speaker overruled the point of order and submitted the following statement:

Representative Simpson raised a point of order against further consideration of **CSHB 11** under Rule 8, Section 3 of the House Rules on the grounds that it violates the one-subject rule, asserting that the bill does not contain only one subject. The point of order is respectfully overruled.

Under Rule 8, Section 3 of the House Rules, "Each bill (except a general appropriations bill. . .) shall contain only one subject." Representative Simpson asserted that **CSHB 11** deals with two separate and distinct subjects: The operation of the Texas Department of Public Safety at the Texas-Mexico border; and the creation of, changes to, or otherwise enhancement of certain criminal offenses, the effects of which are not contained to the border. Representative Simpson also noted that the house has previously sustained similar points of order. *See* 83 H.J. Reg. 1724-1725 (2013) (Miles point of order on **CSHB 947**). Supporters of **CSHB 11** argued that the bill pertains to a single subject, addressing the public safety of Texans related to enhanced border security operations. *See generally* Governor Abbott's proclamation on border security (February 19, 2015).

The chair has reviewed the 17 sections of the bill, the precedent cited by Representative Simpson, and other precedents of the house determined under Rule 8, Section 3 of the House Rules. *See, e.g.*, 83 H.J. Reg. 5150-5151 (2013) (Taylor point of order on **HB 3793**); 81 H.J. Reg. 3760 (2009) (King point of order on **HB 2511**); 78 H.J. Reg. 5586 (2003) (Burnam point of order on **SB 1639**); 76 H.J. Reg. 2912 (1999) (Dutton point of order on **SB 30**). Because **CSHB 11** only pertains to one unifying subject (and the two separate subjects proposed by Representative Simpson are contained in that one subject), there was no violation of Rule 8, Section 3 of the House Rules.

Notwithstanding any other law, the department may implement a 10-hour work day and 50-hour work week for commissioned officers of the department assigned to a department region that includes counties along the Texas-Mexico border.

(b) The report must include information on:

(1) the department's technology policy and information technology system related to providing security in the counties along this state's international border;

(2) the hiring of officers, including officers with previous law enforcement experience, and any call into service of reserve officer corps to provide security in the counties along the border;

(3) the department's assistance at international border checkpoints;

(4) the costs to the department of providing security along the border;

and

(5) the number of investigations, arrests, and prosecutions and the number of traffic violations related to providing security along the border.

(d) The lieutenant governor and the speaker of the house of representatives shall appoint the chair of the committee on an alternating basis. The chair of the committee serves a one-year term that expires September 1 of each year.

(8) Strike proposed Section 411.433(b)(2), Government Code, and substitute the following:

(2) may request from the department, the Parks and Wildlife Department, and the Texas military forces reports and any other information related to border operations considered necessary by the committee;

(9) Immediately after proposed Section 411.433(b), Government Code, insert the following:

(c) The committee may meet and consult with and advise local governments and federal authorities.

(10) Strike the SECTION of the amendment providing for the appointment of committee members by January 1, 2016, and substitute the following:

SECTION \_\_\_\_\_\_. As soon as possible after the effective date of this Act, but not later than September 1, 2015, the appointing officials described by Section 411.432, Government Code, as added by this Act, shall appoint the members of the State Law Enforcement Operations Oversight Committee established under that section. The speaker of the house of representatives shall make the first appointment to chair the committee as provided by that section.

Sec. 411.431. DEFINITIONS. In this subchapter:

(1) "Border" means the border between this state and Mexico.

(2) "Task force" means the Texas Border Operations Oversight Task Force established under this subchapter.

(3) "Texas military forces" has the meaning assigned by Section 437.001.

(4) "Border County" means any county defined as being in the U.S.-Mexico border region as laid out under the 1983 La Paz Agreement for the Protection and Improvement of the Environment in the Border Area.

Sec. 411.432. ESTABLISHMENT OF TEXAS BORDER OPERATIONS OVERSIGHT TASK FORCE. (a) The department shall establish a Texas Border Operations Oversight Task Force to advise the department.

(b) The task force consists of a personnel subcommittee and an infrastructure subcommittee.

(c) Members of the subcommittees shall jointly elect a chair and vice chair of the task force from among the subcommittees' members. The chair and vice chair may not be on the same subcommittee.

(d) Members of the task force are appointed as follows:

(1) each state senator who represents a district located on the border shall appoint one member from the district who lives in a border county as defined above; and

(2) each state representative who represents a district located on the border shall appoint one member from the district who lives in a border county as defined above.

(e) Members of the task force serve a term of six years.

(f) To the extent practicable, the task force must include security experts, training experts, civil rights and civil liberties experts, representatives of faith-based organizations, local law enforcement officials, local governmental officials, and representatives from business and trade organizations.

(g) The task force shall meet at least semiannually and may convene additional meetings as they see fit.

(1) Additional meetings can be called or scheduled by the Chair, Vice Chair, or at the request of a majority of the membership.

(h) Members of the taskforce will be compensated for travel, meals, and lodging expenses incurred in the performance of their duties. Compensation will be in line with established state rates. A member of the taskforce is not entitled to receive compensation for other expenses incurred on or service provided to the taskforce.

(i) The task force is administratively attached to the department.

(j) Chapter 2110 does not apply to the task force.

Sec. 411.433. TASK FORCE; DUTIES. The task force shall:

(1) evaluate policies, strategies, and programs of governmental agencies, including but not limited to DPS, TPWD, and TMD, operating in border counties, as defined above;

(2) develop recommendations for improvements regarding border enforcement policies, strategies, and programs that take into consideration impact on border communities, with particular aim to:

(A) protect due process, the civil and human rights of border residents and visitors, and the private property rights of landowners;

(B) reduce the number of migrant deaths; and

(C) improve the safety of governmental agents and officers and the people with whom they interact;

(3) evaluate existing DPS, TMD, and TPWD training, and develop new or additional training materials and activities for these agencies on dealing with the circumstances of border counties, as defined above:

(4) assess the impact of border enforcement efforts and technologies, including the effect on the civil rights, private property rights, privacy rights, and civil liberties of border communities.

Sec. 411.434. TASK FORCE; POWERS. (a) For the purpose of administering the task force's duties, the task force or a designated member of the task force may:

(1) hold hearings, take testimony, receive evidence, and administer oaths;

(a) Copies of all materials obtained by the task force in the course of their duties shall be maintained by the Texas State Library;

(2) subject to Subsection (b), require, by subpoena or otherwise, the attendance and testimony of a witness and the production of any book, record, correspondence, memorandum, paper, or document the task force or designated member desires in carrying out its duties; and

(3) issue subpoenas that relate to a matter under investigation by the task force.

(b) A subpoena may be issued under this section only by the chair or vice chair of the task force or a recorded vote of two-thirds of the members of the task force.

(c) A subpoena may be issued only if the task force certifies to the director that the issuance is necessary to carry out its duties and that all reasonable efforts will be taken to limit the disclosure of personally identifiable information.

(d) A person authorized to serve process under the Texas Rules of Civil Procedure may serve a subpoena issued under this section. The person shall serve the subpoena in accordance with the Texas Rules of Civil Procedure.

(e) If a person refuses to obey a subpoena issued under this section, the task force or a member of the task force may apply to a district court in Travis County for an order requiring that the person obey the subpoena. If the court finds that good cause existed for the issuance of the subpoena, the court shall order compliance with the subpoena. Failure to obey the court order is punishable by the court as contempt.

(f) This section may not be construed as affecting the investigative and disciplinary procedures of the department with respect to department agents and officers.

Sec. 411.435. TASK FORCE; REPORTS. (a) The task force shall annually submit to the director and to each member of a standing committee of the legislature over homeland security a publicly available report containing information on the activities, findings, and recommendations of the task force for the preceding year.

(b) The director shall brief each standing committee of the legislature with jurisdiction over homeland security on each report required under Subsection (a).

Sec. 411.437. OFFICE OF THE OMBUDSMAN FOR BORDER OPERATIONS-RELATED CONCERNS. (a) In this section, "ombudsman" means the Office of the Ombudsman and component personnel for border operations-related concerns to be located within DPS that is established under this section. (b) The DPS Inspector General shall appoint four ombudsman for border operations-related concerns. One ombudsman is to be located in McAllen, one is to be located in Laredo, one is to be located in Del Rio, and one is to be located in El Paso. These ombudsman shall report directly to the DPS Inspector General.

(c) To serve as ombudsman, a person must be knowledgeable in civil and human rights law.

(d) The ombudsman shall:

(1) receive and address complaints from individuals and employers and facilitate resolution of problems with the border operations components of the department;

(2) by examination of trends in public comments and complaints, identify areas in which individuals and employers have problems in dealing with the border operations components of the department;

(3) has discretion to refer complaints either to the OIG or to the DPS Chain of Command, except for complaints regarding use of force, civil rights violations, and civil liberty violations, which must be referred to OIG.

(4) to the extent practicable, propose changes in the administrative practices of the border operations components of the department to mitigate problems identified under Subdivision (2);

(e) The ombudsman may request that the office of inspector general conduct inspections, investigations, and audits.

(f) The Ombudsman must issue to the OIG, Director, and each standing committee of the legislature with jurisdiction over homeland security a report summarizing complaints received over the prior six months no later than March 1st and September 1st of each year.

(g) Not later than Sept. 1st of each year, the ombudsman shall submit a report to each standing committee of the legislature with jurisdiction over homeland security on the objectives and activities of the ombudsman for the preceding year. Each report must contain:

(1) a full and substantive analysis, in addition to statistical information; and

(2) recommendations for improving the services and responsiveness of the department and any responses received from the department regarding the recommendations.

Sec. 411.439. TRAINING. (a) Department officers and any Texas military forces stationed at the border must be annually certified regarding appropriate training, including academy and in-service training, in the following:

(1) ethics, human rights, civil rights and liberties, constitutional rights, and anti-racial profiling measures;

(2) immigration law as it relates to protections for victims of crime or persecution;

(4) social and cultural sensitivity toward border communities and the impact of border operations on communities and residents;

(5) diversity of immigrant communities residing in the border region;

(6) language and basic cultural awareness of major migrant-sending

nations;

(8) how to respond to grievances and where to refer complaints, to include the Office of the Ombudsman;

(9) local law enforcement agencies, legal and medical services, and any local policies limiting locations of enforcement and community organizations in each border sector;

(10) how to identify and address vulnerable populations, including persons expressing potential grounds for asylum, children, victims of crime and human trafficking, and individuals fleeing persecution or torture;

(b) Training under this section must also ensure:

(1) involvement of instructors from the border, immigrant communities, and the department;

(2) emphasis on a human rights framework as applied to the border region and immigrant communities, as applicable;

(c) As practicable, these training materials should be made publically available at least one month before going into use, and should be open to the public for feedback and suggestion.

(d) The department shall:

(1) develop and implement a publicly available plan on the training and other requirements of this section, including defined implementation goals, actions, measures, and dates; and

(2) annually report to the legislature on the plan and its implementation using specific benchmarks.

Sec. 411.44X ANNUAL DPS REPORT ON BORDER-RELATED ACTIVITIES. The director shall:

(1) collect statistics relating to all DPS border-related law enforcement activities in the border counties as specified above in this legislation, including:

(A) the number of DPS personnel deployed to border related activities;

(B) the number of hours logged by those personnel, specifying both normal and overtime work hours;

(C) the number of vehicle miles logged by DPS aircraft, land vehicles, and marine craft in the performance of DPS border related operations;

(D) the number of vehicle-hours in which DPS land, air, and marine resources were unavailable for use due to need for maintenance;

(E) expenditures on border-related activities, including breakdowns for both operating expenditure and maintenance of land vehicles, air vehicles, marine vehicles, standard personnel costs, overtime costs, technology costs (including operation and maintenance of border related cameras;

(F) the number of border related law enforcement operations undertaken by DPS, specifying:

(1) the number of operations where DPS engaged jointly with, or in a subsidiary role to federal or local law enforcement agencies,

(2) the number of operations where DPS was the lead law enforcement agency in operations undertaken jointly with federal or local law enforcement agencies,

(3) the number of operations where DPS was the sole participating law enforcement agency, and (4) the man-hours and other DPS resources deployed as part of each of these types of operations; (G) state felony arrests made by DPS personnel as part of border related operations, specifying: (1) Arrests made by DPS as part of operations where local or federal law enforcement were participants, and (2) Arrests made by DPS as part of operations where they were the sole participant.  $\overline{(3)}$  That arrests made by federal or local law enforcement as part of operations undertaken jointly with DPS should not be included in these figures. (4) the man-hours and other DPS resources deployed as part of the specific operations leading to the arrests described in points 1 & 2 above. (5) Moreover, for each of the categories laid out in 1 & 2, statistics should be compiled as to the type of felony committed by the arrested individuals; (H) drug, currency, and weapon seizures made by DPS personnel as part of border related operations, specifying: (1) Seizures made by DPS as part of operations where local or federal law enforcement were participants, and (2) Seizures made by DPS as part of operations where they were the sole participant, and (3) The man-hours and other DPS resources deployed as part of the specific operations leading to the arrests described in points 1 & 2 above, and (4) That seizures made by federal or local law enforcement as part of operations undertaken jointly with DPS should not be included in these figures; (I) DPS use of force in border related operations, specifying: (1) Non-lethal uses of force, (2) Lethal uses of force, (3) Use of firearms, whether or not the use resulted in injury or death to a person, and  $\overline{(4)}$  Conditions that led to the use of force; (J) That all of the above statistics provided by DPS can be cross-tabulated by county in which the law enforcement activity occurred, month of year, and time of day. (2) The director shall summarize and issue these statistics in an annual report to be made public no later than September 1 of each year. (A) This annual report should examine intra-year trends as well as including 3, 5, and 10-year comparisons for all data provided. (B) The director should also actively provide copies of this report to the membership of each standing committee in the legislature with jurisdiction

over homeland security.

### **CSHB 11 - REMARKS**

REPRESENTATIVE WALLE: A billion dollars. Let me say that again, \$1 billion. That's how much we've spent on border security for the last four biennia, and now we're planning on spending close to another half a billion dollars on a mission that does not even have a definition. Mr. Speaker, members, I rise today to speak in opposition to **CSHB 11**. I appreciate that Chairman Bonnen and other house members, both democrat and republican, have worked to scale back the overly broad version of this bill. However, even with the hard work done by my colleagues, this bill appears to serve mostly as a vehicle to brandish one's tough-on-immigration stance.

The first few months of this session I have spent listening to long Appropriations hearings on the state's programs and services and their health. We examined and mulled over critical programs. However, it seems that the respective budget committees in each chamber are determined to spend between \$400 and \$800 million in the next two years without much oversight or directive in pursuit of border security. Border security still remains undefined by the state in any form, even though we have already spent over \$1 billion in the last four biennia. Fiscal conservatives seem to have gone silent in their calls for accountability and responsibility with regard to this issue. Even today there were ample opportunities to place safeguards on how the resources are spent. Instead, it seems the goal is to prove how serious we are by the amount of money that we're throwing at this problem.

DPS is poaching off local law enforcement in order to meet the increased personnel targets with help from **CSHB 11**'s provisions for crediting peace officers' service outside of DPS for salary purposes. Losing these good local police officers in our local communities is a risk to our public safety for the rest of the state. My county, Harris County, is host to many of the downstream and more serious effects of cartel activity in terms of drug trafficking and human trafficking. We can't afford to send law enforcement elsewhere when we already have a shortfall of police officers in our communities. It is my sincere hope to continue working with Chairman Otto, Speaker Straus, and the membership to address these concerns of accountability, metrics, and best usage of state resources as we move forward on this strategy.

Renewed focus was placed on the border last summer when the influx of unaccompanied minors, members-children, children from Central America who were fleeing their murderous homeland. Even back then I pleaded for compassion and patience for these children as we tried to find a safe home for these refugees. Unfortunately, at the time and in the months since, the politicization of this situation turned a humanitarian crisis into an indefinite surge where we're spending billions of dollars of money on the border, where we sent troops, National Guard, to the border-guardsmen and contractors-and used and spent an enormous amount of money on law enforcement gear. The numbers show unaccompanied minor crossings decreased, but evidence indicates it was due more to DHS' efforts to debunk rumors that the U.S. was offering refuge, or permisos, to children. And in addition to the Mexican government cracking down on northbound cargo trains, trains such as La Bestia. CSHB 11 and the pieces included in the introduced budget bills taken together are an example of a solution looking for a wrong problem. True immigration enforcement is the jurisdiction of the federal government, and reform of that system must happen at the federal level. We had an opportunity as a state to respond to the humanitarian crisis, but instead we sent our National Guard-sent in our National Guard when they also have families and occupations, and bills, and mortgages to pay. I did my part by working with many of these unaccompanied children, and I represented them in many of their immigration status hearings.

The additional money being contemplated for border security would make a dent in the fiscal note on Representative Huberty's pre-K bill. We could help make sure our hospitals don't go under from the costs of uncompensated care. Or we could make more meaningful investment in our infrastructure, like water and roads. I guarantee you the dollars we spend on these other initiatives will save and improve more Texans' lives than the indefinite expansion of DPS and its authority in the name of border security. Thank you, Mr. Speaker, Mr. Bonnen, and members for allowing me your patience on my amendments and for my closing arguments. And with that, Mr. Speaker, I move that we not pass **CSHB 11**.

REPRESENTATIVE COLEMAN: You've worked with everybody and you've done a good job. One of the things that, I don't think it was appropriate on this bill, but maybe on the appropriations bill or on some other setting, is to ask the federal government to consider funding these initiatives because the State of Texas, you know we have a limited budget. Do you think that's something that we could work on to send, not just letter, but say to Congress, "when you're putting together your budget"—

REPRESENTATIVE D. BONNEN: Absolutely. I mean in all sincerity, God bless you, Representative Coleman. It's one of the things that I make a point to stay focused and comment on regularly. Texas is taking bold steps to fill the gap where the federal government is not meeting their core responsibilities. But it is also our responsibility as Texas legislators to fill that gap, but as much as that being our responsibility, it is also our responsibility to hold the federal government accountable and to not remove their responsibility. Representative Coleman, you have been a stalwart member of this body for many years and you know that when we take on what is a responsibility of the federal government and don't continue to remind them and ask our constituents to remind them that it's really theirs, it becomes ours. I hold that goal with you. It should not become ours; it should be theirs. But one of the main components of this bill is that what is ours is the public safety of Texas citizens inside the border of this state. What this bill helps also do is empower our law enforcement officials to protect our citizens more due to the failure of that federal government in doing their constitutional responsibility.

COLEMAN: Right, and I think that we have enough former members of this body that served both in the house and people, you know, who—Senator Cornyn and Senator Cruz, who understand that we have capacity, but it's limited capacity. And I think it would be a good thing to at least ask if in this next budget would they consider funding some of it or a piece of it.

D. BONNEN: With great respect, Chairman Flynn has a concurrent resolution asking Congress to help us resolve the financial demand that we're taking up because of their choosing not to do their job. With that said, I think it's important that we, as you point out, have many former colleagues that are still our friends that are there serving, and we need to respectfully reach out to them. I would be wrong if I did not mention that Congressman McCaul, who represents parts of Austin down to your and my home area near Houston—he's working hard as chair of the Homeland Security Committee, and my knowledge is that he's trying to get some dollars to help reimburse Texas for some of the things that we've funded over the last 12 months.

COLEMAN: Well, I'm glad to hear that Chairman Flynn has a concurrent resolution, and I think that all of those things are important because maybe we can move something now that the circumstances have changed a little bit to get something put in these budgets that they're working on now.

D. BONNEN: Absolutely, you would think that in Washington with the dollars—you know, as I politely point out to folks on occasion, the entire state budget here in Texas is a rounding error in their deficit spending. I would think that they could find a dollar or two to help us filling the void of their failure to meet their core responsibility.

COLEMAN: Chairman Bonnen, I really appreciate the hard work that you've done on this bill. I know that it's hard to craft something that's 100 percent perfect. But as people have said, this is really a better bill for the consensus of the house.

# **REMARKS ORDERED PRINTED**

Representative Coleman moved to print remarks by Representative Walle.

The motion prevailed.

REPRESENTATIVE GIDDINGS: All of us, I think, are concerned about securing our borders, particularly as it relates to criminal activity. I will say this is a very hefty price tag. Do you believe that this \$4.1 million is in fact close to a good price tag? I know the Legislative Budget Board gave it to us.

D. BONNEN: Well, it would depend on what you count because the reality of it is I think that the \$4 million is very small; I think it's accurate for what this bill does. But I don't want to mislead you, and I know you know this better than most members being a strong member of the Appropriations Committee. But you know our budget is allocating hundreds of millions of dollars to help address the issues that this bill helps enable those dollars to do a better job for Texans. So you know even better than I do the dollars that are being appropriated and allocated to this effort. But to your question, in this bill I don't believe this bill will—should create a higher burden than what is in that fiscal note.

GIDDINGS: We've talked about the federal government not stepping up, whether one believes that or not. If the federal government does step up, is there some way we can de-escalate and not make all these expenditures?

D. BONNEN: Well, my bill doesn't really make hardly any expenditures. That would be a decision for the Appropriations Committee to make when that time happens. Representative Giddings, I hope they do step up and they do meet their core responsibilities to the constitution, but as I've politely said, you won't find me underwater holding my breath expecting them to.

GIDDINGS: Well, as it relates to the \$4.1 million, Mr. Chairman, it certainly provides the legal basis for an appropriation even if the bill itself doesn't appropriate.

D. BONNEN: My point is, ma'am, Appropriations has about \$500 million plus, so that's really where the juice on the dollars is happening.

GIDDINGS: Okay, and just a couple of other questions. One of the things that we're having difficulty with in Dallas, and perhaps in some other urban areas, is hiring police officers basically—because of wages, I suppose. One of the provisions of this bill seems to be that any officer who is commissioned and hired will come in as though they have four years of service, so at a much higher salary level.

D. BONNEN: No, actually that's totally incorrect.

GIDDINGS: Okay, explain it to me.

D. BONNEN: They have to have at least four years of service to be provided the opportunity of getting credit for those four years. The situation now is that if you go hire on at a local county or municipal police department and you're six years into your career and you wanted to go become a part of DPS, you would go to zero, and so there's a disincentive in doing that. So what this bill does is it says for those that are four years or beyond, they can come in at that four-year level.

GIDDINGS: That was exactly my understanding; perhaps I didn't articulate it as well.

D. BONNEN: I apologize; I thought that you had said that anybody could show up and get the four years, that's all.

GIDDINGS: No, they have to be commissioned and they have to have four years of service and then they can come in at the four-year salary level, correct?

D. BONNEN: That is correct, yes.

GIDDINGS: My final question is, can you tell me a little bit more about this reserve officer corps? How many people do you envision being in the corps?

D. BONNEN: I don't really have a vision of how many would be in it, but, you know, I guess my attitude is as many good, retired, or previously commissioned DPS officers who are willing to give their time for free to support doing paperwork and those type of matters—background checks—so that we can have more of our paid troopers out there on the road and in the streets and doing their job of law enforcement. I think it's a great thing for Texas.

GIDDINGS: So they're not paid?

D. BONNEN: The only thing—to give you complete clarity, they're not paid anything except if they had, which would be very rare, travel expenditure. They would be reimbursed for travel expenditure.
