- (f) This subsection expires September 1, 2017. Notwithstanding Subsection (e) of this section, an insurer must refile a request for a refund under this section with the authority not later than November 1, 2015, if the request was:
  - (1) initially made after January 1, 2010;
  - (2) initially made before September 1, 2015; and
- (3) denied before September 1, 2015, solely on the basis of the six-month deadline established by Section 11, Chapter 305 (**HB 1387**), Acts of the 75th Legislature, Regular Session, 1997.
