SB 570 - REMARKS

REPRESENTATIVE STICKLAND: Does this create a new criminal penalty, Representative Sheffield?

REPRESENTATIVE SHEFFIELD: The order must require the county to erect signs to provide notice of the order. The bill would establish a Class C misdemeanor offense for violating an order adopted under the provisions of the bill. That means yes.

STICKLAND: And this is just for one county?

SHEFFIELD: As people who are interested have read through the bill—the commission, by order, shall prohibit or restrict the use of fireworks at a state highway rest area in the unincorporated area of a county if the commissioner's court of the county petitions the commission to adopt the order.

SIMMONS: A retiree of the ERS system?

ALONZO: Yes, sir.

SIMMONS: Are there going to be any particular qualifications other than being a retiree to be on this board?

ALONZO: No, that they're a retiree and that they are a member of the class.

SIMMONS: Do you realize that this board deals with billions and billions of dollars and helps oversee that?

ALONZO: Yes, sir.

SIMMONS: And do you realize that there have been multiple boards throughout this state where this very thing has happened? In fact, in this situation, won't it be controlled by retirees, but has been controlled by members—and they have mismanaged the funds for the people that they're absolutely supposed to protect? In fact, this has happened in our area, would you agree?

ALONZO: Well, sir, there is a process when there are problems, and let me tell you what I believe. What I believe is if there's a problem, for example, someone causes a crime, the law is already there to make sure that they're taken care of.

SIMMONS: The challenge that I have with this—and there are certainly some retirees that would qualify for a board like this, but this is very serious business. If they would have an advisory panel of retirees to make sure that they're discussing the issues of the body, I'm okay with that. But I have major concerns about doing this without selecting a retiree that meets qualifications similar to what the other board members might have—having expertise in investments and retirements, things like this. So this a concern. Now, is this a requirement or is this permissive?

ALONZO: It allows for one of the members—it says may be a retiree. It's Section (b)(1). It doesn't have to be, but it says only one of the elected members of the board may be a retiree.
