Sec. 3891.160. PETITION REQUIRED FOR CERTAIN ASSESSMENTS.

The board may not impose an assessment on territory added to the district by an act of the legislature enacted after May 1, 2015, unless a written petition consenting to the imposition of assessments in the added territory has been filed with the board. The petition must be signed by the owners of at least two-thirds of the assessed value of real property in the added territory subject to assessment according to the most recent certified tax appraisal roll for the county or counties in which the real property is located.

#### **SB 460 - STATEMENT OF LEGISLATIVE INTENT**

REPRESENTATIVE RANEY: Chairwoman Crownover, thank you for your leadership on this bill. I would like to ask a question to clarify the intent of the language in Section 556.051, titled "Authorization to Enter and Inspect." My understanding is the objective of this section is to allow the Texas State Board of Pharmacy to obtain only financial records relevant to a specific complaint related to a pharmacy's operations as regulated under the Texas Pharmacy Act. Is that correct, Madam Chairwoman?

REPRESENTATIVE CROWNCOVER: I simply want to ensure that a pharmacy's financial records are only included as part of the investigation when relevant to the complaint.
