- (6) information, including the source, value, and purpose, related to gifts, grants, or donations to or for use by the task force; and
  - (7) other statistical information.

# CSHB 11 ON SECOND READING (by Thierry, S. Thompson, Zerwas, and Collier)

**CSHB 11**, A bill to be entitled An Act relating to pregnancy-related deaths and maternal morbidity, including postpartum depression.

### Amendment No. 1

Representative Thierry offered the following amendment to **CSHB 11**:

Amend **CSHB 11** (house committee report) by adding the following appropriately numbered SECTIONS to the bill and renumbering subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_\_. Section 193.001, Health and Safety Code, is amended by adding Subsection (a-2) to read as follows:

- (a-2) In prescribing the form and contents of death certificates, the department shall require each death certificate to indicate whether a female decedent was pregnant at the time of death or was pregnant at any time in the year preceding the decedent's death.
- SECTION \_\_\_\_\_. (a) Not later than March 1, 2018, the Department of State Health Services shall revise and make available the forms required by Section 193.001, Health and Safety Code, as amended by this Act.
- (b) Section 193.001, Health and Safety Code, as amended by this Act applies only to a death certificate filed on or after April 1, 2018.

#### Amendment No. 2

Representative Cain offered the following amendment to CSHB 11:

Amend **CSHB 11** (house committee report) by adding the following appropriately numbered SECTION to the bill and renumbering subsequent SECTIONS of the bill accordingly:

SECTION \_\_\_\_\_. Section 34.001(12), Health and Safety Code, is amended to read as follows:

(12) "Pregnancy-related death" means the death of a woman while pregnant or within one year of delivery or end of pregnancy, regardless of the duration and site of the pregnancy, from any cause related to or aggravated by the pregnancy or its management, including direct obstetric death or an underlying aggravating condition causing obstetric death.

### **AMENDMENT NO. 2 - REMARKS**

REPRESENTATIVE WALLE: Representative Cain, so your amendment includes what again?

REPRESENTATIVE CAIN: The "direct obstetric death" and aggravations.

WALLE: All right. Do you know what that means? What is—

CAIN: A "direct obstetric death"?

WALLE: What is "a direct obstetric death or an underlying aggravating condition causing obstetric death"?

CAIN: Yes, sir. That would be pregnancy complications including through pregnancy, delivery, and postpartum. It includes interventions such as abortions, but that's why it's broad—interventions—or incorrect treatment such as malpractice, any chain of events leading to any of those things in the above.

WALLE: Is that defined in the Health and Safety Code? Or how is that—where do you come up with that definition?

CAIN: It's a medical term, sir. It broadens it to give them a year to include anything that may cause it. It's purely—there's no underlying agenda to make this about abortion or anything like that.

WALLE: I didn't want to go down that route, but you mentioned abortion earlier. Is that part of the rationale for this amendment? I just—

CAIN: No, sir. Had I wanted it to be like that, I would have used the word.

WALLE: This whole debate—this whole debate has been about mothers dying, okay? And we tried very, very hard not to get into the debate of abortion. But you mention abortion as part of the definition for a pregnancy-related death.

CAIN: Representative Walle, if I may, the reason I didn't use the word "termination" is that exact reason. This definition is completely as broad as possible and fully encompassing of anything that would deal with the mother's death.

WALLE: So why do we need this amendment on the bill since we're already—we're trying to make sure that we protect the lives of mothers, right, with the task force and bring recommendations exclusive of the debate over abortion, which I think is a very sensitive issue for many members. And I didn't want to go down this route, but you mentioned it when you explained your amendment. So why do we need this amendment?

CAIN: I was simply letting you know how broad it is—that it includes that, but it's not targeted at it.

WALLE: So why do we need your amendment, then?

CAIN: Mr. Walle, I'll leave it to the will of the body. It's acceptable to the author.
