POSTPONED BUSINESS

The following bills were laid before the house as postponed business:

HB 3013 ON SECOND READING
(by Martínez, Canales, and Guillen)

HB 3013, A bill to be entitled An Act relating to incentives to encourage landowners to destroy, remove, or treat citrus trees located in a pest management zone.

HB 3013 was read second time on April 27 and was postponed until 10 a.m. today.

Representative Martínez moved to postpone consideration of **HB 3013** until 10 a.m. Thursday, May 4.

SB 843 ON SECOND READING
(Herrero and Moody - House Sponsors)

SB 843, A bill to be entitled An Act relating to disclosure and use of certain information regarding the Crime Victims' Compensation Act.

SB 843 was considered in lieu of **CSHB 2387**.

SB 843 was read second time and was passed to third reading.

CSHB 2387 - LAID ON THE TABLE SUBJECT TO CALL

HB 1156 ON SECOND READING**(by S. Davis, R. Anderson, Minjarez, Laubenberg, Farrar, et al.)**

HB 1156, A bill to be entitled An Act relating to the unlawful restraint of a dog; creating an offense.

HB 1156 was read second time on April 27 and was postponed until 2 p.m. today.

HB 1156 - POINT OF ORDER

Representative Burrows raised a point of order against further consideration of **HB 1156** under Rule 4, Section 32(c) of the House Rules on the grounds that the bill analysis is incorrect.

The point of order was withdrawn.

HB 1156 - POINT OF ORDER

Representatives Tinderholt and Bell raised a point of order against further consideration of **HB 1156** under Rule 8, Section 1(c) of the House Rules on the grounds that the bill caption is inaccurate.

The speaker sustained the point of order and submitted the following statement:

HB 1156's caption reads "relating to the unlawful restraint of a dog; creating an offense." Representatives Bell and Tinderholt assert that this caption violates Rule 8, Section 1(c) of the House Rules, which requires bills "that would create a criminal offense, increase the punishment for an existing offense or category of offenses, or change the eligibility of a person for community supervision, parole, or mandatory supervision" to "include a short statement at the end of its title or caption indicating the general effect of the bill on the offense, punishment, or eligibility."

HB 1156 prohibits various forms of "unlawful restraint" of a dog. The bill specifies that "a person commits an offense if the person knowingly violates this subchapter. The restraint of each dog with respect to which there is a violation is a separate offense." Further, the bill makes the offense a Class C misdemeanor, punishable by a fine not to exceed \$500, with repeat additional offenses a Class B misdemeanor, punishable by a fine not to exceed \$2,000, confinement in jail for a term not to exceed 180 days, or both such fine and confinement. Thus, **HB 1156** creates a criminal offense, not a civil offense. Therefore, under Rule 8, Section 1(c), **HB 1156**'s caption must include a short statement indicating the general effect of the bill on the criminal offense.

Representative Tinderholt urges that Rule 8, Section 1(c), applies to all offenses, and he identifies the deficiency as failure to specify what type of offense (in this case, criminal) the bill creates. Representative Bell reads the rule as applying to criminal offenses, though he agrees that the caption is deficient, noting that even the example caption language in the House Rules, which was developed in conjunction with the Texas Legislative Council, says "creating a *criminal* offense," (emphasis added), and saying "creating an offense" is inadequate.

When Rule 8, Section 1(c), was introduced, its proponent was clear that he wanted to create a rule that would allow members to identify bills creating criminal penalties, increasing the punishment for a criminal offense or offenses, or changing eligibility for parole, community supervision, or mandatory supervision. Consistent with this intent, the express language of the rule addresses criminal offenses, not civil offenses. If the rule had been intended to warn, generally, of the creation of any type of offense, **HB 1156**'s caption might be adequate.

The fact that the rule applies solely to criminal offenses, however, does not save this caption. The term "offense" is not limited to only criminal offenses. See, e.g., Tex. Code Crim. Proc. Art. 103.0031, Tex. Transp. Code §§682.002, 682.006, and 682.007 (Texas statutes dealing with civil offenses (The Revisor's Notes to §682.007 even state that the revised law adds "civil" to "offense" for clarity)). Stating that a bill creates "an offense" fails to comport with the letter and spirit of a rule that seeks to highlight bills that create criminal offenses. The chair notes that this defect has the potential to impact 32 house bills that were introduced with the vague phrase "creating an offense" in the caption as well as any other bill the caption for which has been amended to contain this phrase. Most of the introduced house bills creating a criminal offense appear to have a correct caption. For those that do not, members who believe a point of order will be called on their bill may wish to amend their bill's caption in committee or, if a senate companion exists, seek to pass the senate bills, which are not bound by the house's caption rules in Rule 8, Section 1(b)-(d).

HB 1156 was returned to the Committee on Public Health.

Art. 46B.082. TRANSPORTATION OF DEFENDANT. (a) On notification from the court under Article 46B.078, the sheriff of the county in which the court is located or the sheriff's deputy [~~designee~~] shall transport the defendant to the court.

(5) On page 28, line 3, between "located" and the underlined period, insert "or the sheriff's deputy".

(6) On page 28, line 3, between "sheriff" and "shall", insert "or sheriff's deputy".

(7) On page 28, line 15, between "sheriff" and "having", insert "or sheriff's deputy".

Amendment No. 3

Representative Price offered the following amendment to **CSHB 12**:

(j-1) To the extent money appropriated to the commission to implement this section for a fiscal year remains available to the commission after the commission selects grant recipients for the fiscal year, the commission shall make grants available using the money remaining for the fiscal year through a competitive request for proposal process, without regard to the limitation provided by Subsection (d-2).

Amendment No. 4 was adopted.

Amendment No. 5

Representative Murr offered the following amendment to **CSHB 12**:

Amend **CSHB 12** (house committee printing) by adding the following appropriately numbered SECTIONS to the bill and renumbering subsequent SECTIONS of the bill accordingly:

SECTION _____. Subchapter D, Chapter 46B, Code of Criminal Procedure, is amended by adding Article 46B.091 to read as follows:

Art. 46B.091. JAIL-BASED COMPETENCY RESTORATION PROGRAM IMPLEMENTED BY COUNTY. (a) In this article:

(1) "Commission" means the Health and Human Services Commission.

(2) "Executive commissioner" means the executive commissioner of the Health and Human Services Commission.

(b) A county or counties jointly may develop and implement a jail-based competency restoration program.

(c) A county that implements a program under this article shall contract with a provider of jail-based competency restoration services that is a local mental health authority or local behavioral health authority that is in good standing with the commission, which may include an authority that is in good standing with the commission and subcontracts with a provider of jail-based competency restoration services.

(d) A jail-based competency restoration program must:

(1) provide jail-based competency restoration services through the use of a multidisciplinary treatment team that are:

(A) directed toward the specific objective of restoring the defendant's competency to stand trial; and

(B) similar to other competency restoration programs;

(2) employ or contract for the services of at least one psychiatrist;

(3) provide jail-based competency restoration services through licensed or qualified mental health professionals;

(4) provide weekly competency restoration hours commensurate to the hours provided as part of a competency restoration program at an inpatient mental health facility;

(5) operate in the jail in a designated space that is separate from the space used for the general population of the jail;

(6) ensure coordination of general health care;

(7) provide mental health treatment and substance use disorder treatment to defendants, as necessary, for competency restoration; and

(8) supply clinically appropriate psychoactive medications for purposes of administering court-ordered medication to defendants as applicable and in accordance with Article 46B.086 of this code or Section 574.106, Health and Safety Code.

(e) The executive commissioner shall adopt rules as necessary for a county to develop and implement a program under this article. The commission shall, as part of the rulemaking process, establish contract monitoring and oversight requirements for a local mental health authority or local behavioral health authority that contracts with a county to provide jail-based competency restoration services under this article. The contract monitoring and oversight requirements must be consistent with local mental health authority or local behavioral health authority performance contract monitoring and oversight requirements, as applicable.

(f) The commission may inspect on behalf of the state any aspect of a program implemented under this article.

(g) A psychiatrist or psychologist for the provider shall conduct at least two full psychiatric or psychological evaluations of the defendant during the period the defendant receives competency restoration services in the jail. The psychiatrist or psychologist must conduct one evaluation not later than the 21st day and one evaluation not later than the 55th day after the date the defendant is committed to the program. The psychiatrist or psychologist shall submit to the court a report concerning each evaluation required under this subsection.

(h) If at any time during a defendant's commitment to a program implemented under this article the psychiatrist or psychologist for the provider determines that the defendant has attained competency to stand trial:

(1) the psychiatrist or psychologist for the provider shall promptly issue and send to the court a report demonstrating that fact; and

(2) the court shall consider that report as the report of an expert stating an opinion that the defendant has been restored to competency for purposes of Article 46B.0755(a) or (b).

(i) If at any time during a defendant's commitment to a program implemented under this article the psychiatrist or psychologist for the provider determines that the defendant's competency to stand trial is unlikely to be restored in the foreseeable future:

(1) the psychiatrist or psychologist for the provider shall promptly issue and send to the court a report demonstrating that fact; and

(2) the court shall:

(A) proceed under Subchapter E or F and order the transfer of the defendant, without unnecessary delay, to the first available facility that is appropriate for that defendant, as provided under Subchapter E or F, as applicable; or

(B) release the defendant on bail as permitted under Chapter 17.

(j) If the psychiatrist or psychologist for the provider determines that a defendant committed to a program implemented under this article has not been restored to competency by the end of the 60th day after the date the defendant was committed to the program:

(1) for a defendant charged with a felony, the defendant shall be transferred, without unnecessary delay and for the remainder of the period prescribed by Article 46B.073(b), to the first available facility that is appropriate for that defendant as provided by Article 46B.073(c) or (d); and

(2) for a defendant charged with a misdemeanor, the court may:

(A) order a single extension under Article 46B.080 and, notwithstanding Articles 46B.073(e) and (f), the transfer of the defendant without unnecessary delay to the appropriate mental health facility or residential care facility as provided by Article 46B.073(d) for the remainder of the period under the extension;

(B) proceed under Subchapter E or F;

(C) release the defendant on bail as permitted under Chapter 17; or

(D) dismiss the charges in accordance with Article 46B.010.

(k) Unless otherwise provided by this article, the provisions of this chapter, including the maximum periods prescribed by Article 46B.0095, apply to a defendant receiving competency restoration services, including competency restoration education services, under a program implemented under this article in the same manner as those provisions apply to any other defendant who is subject to proceedings under this chapter.

(l) This article does not affect the responsibility of a county to ensure the safety of a defendant who is committed to the program and to provide the same adequate care to the defendant as is provided to other inmates of the jail in which the defendant is located.

SECTION _____. Not later than November 1, 2017, the executive commissioner of the Health and Human Services Commission shall adopt the rules described by Article 46B.091(e), Code of Criminal Procedure, as added by this Act.

CSHB 1724 - POINT OF ORDER

Representative Stickland raised a point of order against further consideration of **CSHB 1724** under Rule 8, Section 1(b) of the House Rules on the grounds that the bill caption is inaccurate.

The speaker sustained the point of order and submitted the following statement:

Under Rule 8, Section 1(b) of the House Rules, "A house bill that would impose, authorize, increase, or change the rate or amount of a tax, assessment, surcharge, or fee must include a short statement at the end of its title or caption indicating the general effect of the bill on the tax, assessment, surcharge, or fee"

CSHB 1724 repeals the Parks and Wildlife Code provisions relating to the shrimp license buyback account and creates the commercial license buyback account. For the most part, the bill's features, including the fee complained of by Representative Stickland, already exist in statute, but they relate to the shrimp license buyback account rather than the new commercial license buyback account. In effect, the features of the repealed shrimp account are transferred, with some changes (including having a percentage of license transfer fees for commercial crab and finfish licenses deposited into the commercial license buyback account), to apply to the commercial account. The consolidation of money into the commercial license buyback account was intended to protect the Texas fishing industry by preventing funding in accounts related to various marine animals from being diverted to purposes other than license buybacks. Representative Stickland argues that the changes made by **CSHB 1724**, achieved by repealing one account and creating another in its place, amount to imposing a new fee that is not reflected in the caption.

Within the four corners of the bill, the bill's plain language imposes a fee increase: "In addition to the fee increases the department is authorized to make under this code, the department shall increase by 15 percent" Although an equal existing (but different) fee is repealed by the bill (and would continue to exist under the provisions relating to the shrimp license buyback account even if **CSHB 1724** is never passed), the creation of the new account with an identical fee, which applies to identical entities, does, in fact, violate the black and white letter of Rule 8, Section 1(b). The point of order is sustained.

REPRESENTATIVE SCHOFIELD: Mr. Smithee, you and I have discussed this, and I want to ask these questions for the purpose of legislative intent. On page 5 of the bill, starting on line 20, we have a provision that says, "if a witness makes an in-court identification of the accused, that identification is only admissible if it's accompanied by evidence of the details of any prior identification." My question to you for the purpose of legislative intent is, is this intended to be only if there was a prior identification made to law enforcement in some—either in a lineup or an investigation?

REPRESENTATIVE SMITHEE: Well, typically, yes, because it only applies when there's been a prior identification. It simply allows the defendant and his counsel to have access to the fact that there's been a prior identification and the circumstances of that identification before they get into trial. And the prosecution would set that up as a predicate to the witness testifying that he could identify that defendant as having committed the crime.

SCHOFIELD: So it's your understanding that the prosecution is not prevented from admitting the eyewitness testimony unless there has been a prior eyewitness statement to law enforcement or to the DA and that has not been given to the defendant?

SMITHEE: And that case would only come up if the prosecution was as surprised as the defendant when the witness blurted out, "That's the guy that did it." That's not as a practical matter going to happen very often, if at all. And so yes, if the prosecutor doesn't know and has no reason to know, then there's no way he could make any predicate on that.

SCHOFIELD: So the purpose of this is if there's been a lineup, if there's been a mug shot book, if the officer has questioned this witness and asked him—that prior identification is a sine qua non to getting the live testimony in.

G. BONNEN: Okay, and this bill, does it relate to the health of minors in the state?

PRICE: It does.

G. BONNEN: Why are we creating a special exemption for those under Chapter 201 of the Occupations Code?

PRICE: Well, it actually strengthens the safety of the student athlete. We had previously, six years ago, listed a coach. We had listed a physician. We had listed licensed health care professionals. We had listed the parent or guardian. We did not list a chiropractor. So this just adds to the list of folks who could, if they believe that a student athlete sustained a concussion, remove them from play.

G. BONNEN: Thank you, I appreciate that. Do chiropractors have special training that would help them identify neurological conditions such as concussions?

PRICE: I know that they have training. The extent of that training with respect to neurological conditions, I believe some of them get specialized training, but I'm not sure that's in the standard curriculum for them in chiropractic school. However, that's not really what this bill would go toward. You wouldn't have to have that kind of training to be listed in this.

G. BONNEN: So the bill is not intended to expand their scope of practice, is that correct?

PRICE: It is absolutely not intended to expand scope of practice.

G. BONNEN: So to be clear, we are not expanding on one's scope of practice, and we're merely identifying those who are authorized on a field to remove a player who's been potentially injured.

PRICE: That's correct.

REPRESENTATIVE SHEFFIELD: I didn't have a chance to talk to you before this, I apologize. So this bill specifies the chiropractor may remove the student from competition. Does this also include the chiropractor judging whether or not the student can return to competition?

PRICE: It does not. It just talks about who can remove the student from play.
