#### SB 1289 - REMARKS

REPRESENTATIVE ANCHIA: As the chair of the International Trade and Governmental Affairs Committee, oftentimes I get communications from our partners in trade about certain bills. It's not my intention to speak against this bill at all, but I did want to read into the record concerns raised by some of our treaty partners from the Canadian government, who obviously we've had a 20-year rules-based trading relationship with. And I just wanted to read it for the record.

The U.S.-Canada steel industry is deeply integrated and has significant cross-ownership. "Buy America" restrictions can disrupt efficient business operations, making projects more expensive. Canada-U.S. trade in iron and steel is largely balanced, and the United States has a trade surplus in iron and steel on products with Canada. In 2016, Texas sold over 461 million iron and steel products to Canada while importing 357 million of the same products in return, resulting in a trade surplus for Texas of about \$106 million. Both countries have a persistent trade deficit in iron and steel products with the rest of the world. However, we are natural allies. While Canada may not be the target of "Buy America" rules, we pay for them disproportionately given our volume of trade and deeply integrated supply chains. Currently, Canada procurement markets are open to U.S. suppliers at both federal and sub-federal levels. In terms of Canada-U.S. reciprocity, while U.S. suppliers win more than nine percent of U.S. federal contracts, Canadian suppliers win a mere 0.15 percent of U.S. federal contracts.

As we are voting on this bill, we really should consider the impacts on our treaty partners and understand that while well-intentioned, many times these provisions included in state and federal law can have an impact on the efficient operations of the marketplace. Again, not my intention to speak against, just considerations that I'd ask the body to have.

# SB 179 ON THIRD READING (Minjarez - House Sponsor)

**SB 179**, A bill to be entitled An Act relating to harassment, bullying, and cyberbullying of a public school student or minor and certain mental health programs for public school students.

# SB 179 - REMARKS

REPRESENTATIVE MINJAREZ: This bill, named in the memory of David Molak, will ensure the proper balance between eliminating cyberbullying and helping the Texas children who need it the most.

REPRESENTATIVE MOODY: Thank you all for giving me a few moments today. I was going to give these remarks yesterday, but given the atmosphere, I thought it was better to do it today. When I first came to this house I was 27 years old, and until then I'd been a prosecutor. You see heartbreaking things day in and day out when you're a prosecutor. You see the worst things people do to one another. Loved ones who never come back, hearts that can never be healed—it hardens you. That hard exterior is necessary because the things you're doing and seeing are immediate. You're dealing with real people right there in front of you who are looking to you for help and for justice.

When I joined this body, I quickly found that things were different in the legislature. Often we come to this floor and take votes without having to look someone in the eye. We make choices based on abstract concepts that sometimes obscure those real people our decisions affect. But sometimes we do get to meet with those people, and sometimes that stays with you. For me, for this bill, I got to do that with Brandy Vela's mom and dad. Brandy was a bright, beautiful young woman who had her whole life ahead of her. But for everything so positive people could see on the outside, there was a hidden world of pain and abuse she also lived in. That world was online. Like every single one of us these days, she used technology as an integral part of her daily life. And when she did, some people who use the anonymity of the Internet, people who didn't have to look her in the eye, antagonized her over and over relentlessly. It went on so long, and it was so abusive, that actually she became isolated and hopeless. She was trapped by what these cowards behind keyboards were doing to her, and her shame kept her from getting the help she needed to deal with it. And when the day came that she couldn't take it anymore, she took out a gun, and she shot herself dead in front of her family.

Brandy's story hit me hard because a lot has changed for me since I was that 27-year-old kid who somehow got the honor of standing on this house floor. I've become the father of two young boys since then. That hard exterior of a prosecutor came down right away. And when I heard the Vela family story, I heard that story as a parent. For those of you that are fathers, for those of you that are mothers, you know what I'm talking about. To think about that happening to me, to lose one of my sons that way, to think about the crippling pain that could bring them to that place—it's hard to even think about it. But I guarantee you, Brandy Vela's mom and dad won't ever be able to think about anything else again. They handed me this card when we spoke. It's a funeral card, a funeral card for a child. I kept it to remind me of why we do what we do here.

This bill is about real world issues that affect people in a very real way. We need to update our laws to keep pace with the times. Young people aren't just hurting each other on the playground these days. This bill isn't designed to stifle free speech or criminalize something harmless. It's narrowly tailored toward stopping this kind of thing from happening and providing the mental health support our young people need. It's a chance to make a difference. The next Brandy Vela could be any young person in this state. It could be any one of our children who are facing pressures none of us ever had to deal with. We have a chance right here, right now, to do something about that. Sadly, there are times that we fail children on this house floor. Let's not do that today.

REPRESENTATIVE FAIRCLOTH: I am sad to say that Brandy Vela lived in my district. She's from Texas City, Texas. Within the last six months, we have had two young people take their lives as a result of the fact that someone else saw it necessary to make themselves feel powerful by demeaning, demoralizing, and driving someone to the brink of extinction. If we could alleviate for one second the suffering that these families have to endure for the rest of their lives, we should do that. That's why when I met with the Vela family, Ina and I agreed to work together because she had a similar case in San Antonio. Each day, hundreds of thousands of kids do not attend school because of bullying—because of bullying. We have cyber keyboard cowards that love to jump on social media and terrorize someone else's life because they disagree with something they said or an opinion that they may hold. It's unconscionable.

I have five children, except 20 years ago one of them passed away, a two-and-a-half-year-old son. The pain of that will never leave me ever. It is time to treat each other with respect, and that starts here. That starts here in this house. You can disagree with my policy, but to attack me personally, it's not acceptable. And the same standard goes for me with my interaction with you. We have to set the example here. We can't just go and say, "The problem is in the schools; the problem is with young people." Because it's not; it's not. It doesn't stop there. It's how we treat each other. It's how we walk. It's how we talk. It's how we listen and seek to understand to make a difference. This is important. This is an important step. We're providing some tools for teachers, for law enforcement, for counselors, for parents to be able to help young people have a proper perspective of who they are. So I encourage you today not just to pass this bill and walk away and say, "We did something really good." I want to challenge you today to look

into your own life and say, "Is there someone out there that I've made feel less of a person? That I've intentionally gone out of my way to hurt? That I've expressed my anger toward?"

REPRESENTATIVE DALE: I don't speak to you here today, because I'm confident that you're going to do the right thing on this bill, but I speak to anyone who is watching. And I speak particularly to the news media as well, asking assistance to help get the word out about just how pervasive this problem is in our modern era. I'm talking to the teachers out there, to the parents, to the aunts, the uncles, the brothers and sisters.

Kids that are bullied don't tell their parents they're being bullied, because their parents would intervene. They keep it inside, but sometimes they tell a friend. We need to be talking to our kids' friends. It is not bad for parents to monitor your kids' social media. You have to. It's your obligation, because they're saying things online they won't say to you. They say it to their friends, and you can intervene and stop these things from happening. I've seen it. I've seen it directly. We've had friends that have intervened with other families to prevent tragedies, and it really does take that community that we all desire to have—people that are looking out for each other. But these young people, they just don't know how to handle it. They just bottle it up inside, and then, then the worst thing can happen.

So for those of you in the media that are listening today, please write about this and urge parents, friends, family to be more involved and more conscious and just look for the small things that they can act upon and prevent these tragedies. One is too many. It's just—it's got to stop, and we all have an obligation of doing it.

REPRESENTATIVE HUBERTY: This legislation is so important. I've been honored to serve on the Public Education Committee the last four sessions. We've done a lot of great work, but this is one of the most important pieces of legislation that we have ever passed. I'm grateful that we were able to pass this for the family and all of you that have children. Many of you know my story. I have a son who has some special requirements and special needs, and he gets picked on. It's heart-wrenching. For those children that can't defend themselves, we as a body have to defend them. This is an important vote. This is a vote where it's my expectation that you don't ever want to have this happen to the child that you have or ever have to have to attend a funeral. That is not the way the world works. We are supposed to go before our children. If we can do one thing this legislative session and have the opportunity to protect children, we have two weeks left to be adults. The citizens are watching. They expect us to be adults. I hope you will stand with me and unanimously support this wonderful piece of legislation.

MINJAREZ: This has been an incredibly, incredibly long road. I started working on this issue at the end of the 84th Legislative Session when the Vasquez family in San Antonio reached out to me because their son was a victim of just horrendous cyberbullying. And during that whole journey of getting here today, I have met so many families throughout the state that have lost loved ones, and I knew that we had a responsibility to Texas children. We could no longer turn a blind eye to what was going on. I want to thank the joint authors who helped me with this bill and everyone in this building who played an integral part in helping me get it out of the house today, to get it out of the finish line. And I want to thank Senator Menendez for taking on this issue with me and being the champion in the senate. With that said, members, on behalf of the Vasquez family, the Molak family, the Hess family, the Scott family, the Vela family, Roxanne Jones, and Abigail Dickson, and all of Texas' children, I move passage.
