**CSHB 4268** (by Sanford), A bill to be entitled An Act relating to the creation of the Celina Municipal Management District No. 2; providing a limited authority of eminent domain; providing authority to issue bonds and impose assessments, fees, and taxes. (Cain, Rinaldi, Shaheen, Simmons, Springer, Stickland, and Zedler recorded voting no.)

**CSHB 4270** (by Isaac), A bill to be entitled An Act relating to the Anthem Municipal Utility District; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes. (Cain, Rinaldi, Shaheen, Simmons, Springer, Stickland, and Zedler recorded voting no.)

**CSHB 4275** (by Lozano), A bill to be entitled An Act relating to the creation of the Ingleside Improvement District; providing authority to issue bonds; granting limited power of eminent domain; providing authority to impose assessments, fees, and taxes. (Cain, Rinaldi, Shaheen, Simmons, Springer, Stickland, and Zedler recorded voting no.)

### **Amendment No. 1**

Representative Lozano offered the following amendment to **CSHB 4275**:

Amend **CSHB 4275** (house committee report) by striking all below the enacting clause and substituting the following:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 7998 to read as follows:

#### CHAPTER 7998. INGLESIDE MUNICIPAL UTILITY DISTRICT NO. 1

##### SUBCHAPTER A. GENERAL PROVISIONS

Sec. 7998.001. DEFINITIONS. In this chapter:

(1) "Board" means the district's board of directors.

(2) "Commission" means the Texas Commission on Environmental Quality.

(3) "Director" means a board member.

(4) "District" means the Ingleside Municipal Utility District No. 1.

Sec. 7998.002. NATURE OF DISTRICT. The district is a municipal utility district created under Section 59, Article XVI, Texas Constitution.

Sec. 7998.003. CONFIRMATION AND DIRECTORS' ELECTION REQUIRED. The temporary directors shall hold an election to confirm the creation of the district and to elect five permanent directors as provided by Section 49.102, Water Code.

Sec. 7998.004. CONSENT OF MUNICIPALITY REQUIRED. The temporary directors may not hold an election under Section 7998.003 until each municipality in whose corporate limits or extraterritorial jurisdiction the district is located has consented by ordinance or resolution to the creation of the district and to the inclusion of land in the district.

Sec. 7998.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a) The district is created to serve a public purpose and benefit.

(b) The district is created to accomplish the purposes of:

(1) a municipal utility district as provided by general law and Section 59, Article XVI, Texas Constitution; and

(2) Section 52, Article III, Texas Constitution, that relate to the construction, acquisition, improvement, operation, or maintenance of macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads.

Sec. 7998.006. INITIAL DISTRICT TERRITORY. (a) The district is initially composed of the territory described by Section 2 of the Act enacting this chapter.

(b) The boundaries and field notes contained in Section 2 of the Act enacting this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process does not affect the district's:

(1) organization, existence, or validity;

(2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and interest on a bond;

(3) right to impose a tax; or

(4) legality or operation.

#### SUBCHAPTER B. BOARD OF DIRECTORS

Sec. 7998.051. GOVERNING BODY; TERMS. (a) The district is governed by a board of five elected directors.

(b) Except as provided by Section 7998.052, directors serve staggered four-year terms.

Sec. 7998.052. TEMPORARY DIRECTORS. (a) The temporary board consists of:

(1) Richard Dupriest;

(2) Raymond F. Wetegrove;

(3) Joseph M. Wetegrove;

(4) Jane Helm; and

(5) Steven Ray.

(b) Temporary directors serve until the earlier of:

(1) the date permanent directors are elected under Section 7998.003; or

(2) the fourth anniversary of the effective date of the Act enacting this chapter.

(c) If permanent directors have not been elected under Section 7998.003 and the terms of the temporary directors have expired, successor temporary directors shall be appointed or reappointed as provided by Subsection (d) to serve terms that expire on the earlier of:

(1) the date permanent directors are elected under Section 7998.003; or

(2) the fourth anniversary of the date of the appointment or reappointment.

(d) If Subsection (c) applies, the owner or owners of a majority of the assessed value of the real property in the district may submit a petition to the commission requesting that the commission appoint as successor temporary directors the five persons named in the petition. The commission shall appoint as successor temporary directors the five persons named in the petition.

#### SUBCHAPTER C. POWERS AND DUTIES

Sec. 7998.101. GENERAL POWERS AND DUTIES. The district has the powers and duties necessary to accomplish the purposes for which the district is created.

Sec. 7998.102. MUNICIPAL UTILITY DISTRICT POWERS AND DUTIES. The district has the powers and duties provided by the general law of this state, including Chapters 49 and 54, Water Code, applicable to municipal utility districts created under Section 59, Article XVI, Texas Constitution.

Sec. 7998.103. AUTHORITY FOR ROAD PROJECTS. Under Section 52, Article III, Texas Constitution, the district may design, acquire, construct, finance, issue bonds for, improve, operate, maintain, and convey to this state, a county, or a municipality for operation and maintenance macadamized, graveled, or paved roads, or improvements, including storm drainage, in aid of those roads.

Sec. 7998.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road project must meet all applicable construction standards, zoning and subdivision requirements, and regulations of each municipality in whose corporate limits or extraterritorial jurisdiction the road project is located.

(b) If a road project is not located in the corporate limits or extraterritorial jurisdiction of a municipality, the road project must meet all applicable construction standards, subdivision requirements, and regulations of each county in which the road project is located.

(c) If the state will maintain and operate the road, the Texas Transportation Commission must approve the plans and specifications of the road project.

Sec. 7998.105. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE OR RESOLUTION. The district shall comply with all applicable requirements of any ordinance or resolution that is adopted under Section 54.016 or 54.0165, Water Code, and that consents to the creation of the district or to the inclusion of land in the district.

Sec. 7998.106. DIVISION OF DISTRICT. (a) The district may be divided into two or more districts only if:

(1) the district has no outstanding bonded debt;

(2) the district is not imposing ad valorem taxes; and

(3) the requirements of Subsection (i), as applicable, are satisfied.

(b) This chapter applies to any new district created by the division of the district, and a new district has all the powers and duties of the district.

(c) A new district created by the division of the district may not, at the time the new district is created, contain any land outside the area described by Section 2 of the Act enacting this chapter.

(d) The board, on its own motion or on receipt of a petition signed by the owner or owners of a majority of the assessed value of the real property in the district, may adopt an order dividing the district.

(e) The board may adopt an order dividing the district before or after the date the board holds an election under Section 7998.003 to confirm the district's creation.

(f) An order dividing the district shall:

(1) name the new district;

(2) include the metes and bounds of each new district;

(3) appoint temporary directors for each new district; and

(4) provide for the division of assets and liabilities between the district and each new district.

(g) On or before the 30th day after the date of adoption of an order dividing the district, the district shall file the order with the commission and record the order in the real property records of each county in which the district is located.

(h) A new district created by the division of the district shall hold a confirmation and directors' election as required by Section 7998.003.

(i) If the district is located wholly or partly in the corporate limits or the extraterritorial jurisdiction of a municipality, the district may not divide under this section unless the municipality by resolution or ordinance consents to the division of the district. If the district is not located wholly or partly in the corporate limits or extraterritorial jurisdiction of a municipality, the district may not divide under this section unless the commissioners court of each county in which the district is wholly or partly located first adopts a resolution or order in support of the division of the district.

(j) Any new district created by the division of the district must hold an election as required by this chapter to obtain voter approval before the district may impose a maintenance tax or issue bonds payable wholly or partly from ad valorem taxes.

#### SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

Sec. 7998.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The district may issue, without an election, bonds and other obligations secured by revenue other than ad valorem taxes.

(b) The district must hold an election in the manner provided by Chapters 49 and 54, Water Code, to obtain voter approval before the district may impose an ad valorem tax or issue bonds payable from ad valorem taxes.

(c) The district may not issue bonds payable from ad valorem taxes to finance a road project unless the issuance is approved by a vote of a two-thirds majority of the district voters voting at an election held for that purpose.

Sec. 7998.152. OPERATION AND MAINTENANCE TAX. (a) If authorized at an election held under Section 7998.151, the district may impose an operation and maintenance tax on taxable property in the district in accordance with Section 49.107, Water Code.

(b) The board shall determine the tax rate. The rate may not exceed the rate approved at the election.

Sec. 7998.153. WATER AND SEWER RATES. Notwithstanding any other law, the district shall establish the same rates for residential and commercial classes of customers for the provision of water and sewer services. For purposes of this section, the commercial class may not include apartment complexes or other multifamily dwellings.

#### SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

Sec. 7998.201. AUTHORITY TO ISSUE BONDS AND OTHER OBLIGATIONS. The district may issue bonds or other obligations payable wholly or partly from ad valorem taxes, impact fees, revenue, contract payments, grants, or other district money, or any combination of those sources, to pay for any authorized district purpose.

Sec. 7998.202. TAXES FOR BONDS. At the time the district issues bonds payable wholly or partly from ad valorem taxes, the board shall provide for the annual imposition of a continuing direct ad valorem tax, without limit as to rate or amount, while all or part of the bonds are outstanding as required and in the manner provided by Sections 54.601 and 54.602, Water Code.

Sec. 7998.203. BONDS FOR ROAD PROJECTS. At the time of issuance, the total principal amount of bonds or other obligations issued or incurred to finance road projects and payable from ad valorem taxes may not exceed one-fourth of the assessed value of the real property in the district.

SECTION 2. The Ingleside Municipal Utility District No. 1 initially includes all the territory contained in the following area:

Being 625 acres, more or less, out of the Wm McDonough Survey, Abstract 184, the R.S. Williamson Survey, Abstract 283, the Edmond St. John Survey, Abstract 250, the Louis Von Zacharias Survey, Abstract 272, and the John Robinson Survey, Abstract 226, all tracts located in the City of Ingleside, San Patricio County, Texas.

SECTION 3. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, Government Code.

(b) The governor, one of the required recipients, has submitted the notice and Act to the Texas Commission on Environmental Quality.

(c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the lieutenant governor, and the speaker of the house of representatives within the required time.

(d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

SECTION 4. (a) If this Act does not receive a two-thirds vote of all the members elected to each house, Subchapter C, Chapter 7998, Special District Local Laws Code, as added by Section 1 of this Act, is amended by adding Section 7998.107 to read as follows:

Sec. 7998.107. NO EMINENT DOMAIN POWER. The district may not exercise the power of eminent domain.

(b) This section is not intended to be an expression of a legislative interpretation of the requirements of Section 17(c), Article I, Texas Constitution.

SECTION 5. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2017.

Amendment No. 1 was adopted.

Representative Bell moved to lay **HB 4282** on the table subject to call, and the motion prevailed.

**CSHB 4287** (by Fallon), A bill to be entitled An Act relating to the powers and duties of the Smiley Road Water Control and Improvement District. (Cain, Simmons, Springer, and Stickland recorded voting no.)

**CSHB 4294** (by Holland), A bill to be entitled An Act relating to the creation of the North Celina Municipal Management District No. 3; providing a limited authority of eminent domain; providing authority to impose taxes, levy assessments, and issue bonds. (Cain, Rinaldi, Shaheen, Simmons, Springer, Stickland, and Zedler recorded voting no.)

**CSHB 4297** (by Miller), A bill to be entitled An Act relating to the creation of Telfair Tract 5 Commercial Management District; providing authority to issue bonds; providing authority to impose assessments, fees, or taxes. (Cain, Rinaldi, Shaheen, Simmons, Springer, Stickland, and Zedler recorded voting no.)

**HB 4298** (by Oliverson), A bill to be entitled An Act relating to the creation of the Harris County Municipal Utility District No. 553; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes. (Cain, Rinaldi, Shaheen, Simmons, Springer, Stickland, and Zedler recorded voting no.)

**SB 2271** (Phelan - House Sponsor), in lieu of **HB 4299**, A bill to be entitled An Act relating to the creation of Port Neches Improvement District; providing authority to issue bonds; providing authority to impose assessments, fees, or taxes. (Cain, Rinaldi, Shaheen, Simmons, Springer, Stickland, and Zedler recorded voting no.)

Representative Phelan moved to lay **HB 4299** on the table subject to call, and the motion prevailed.

**CSHB 4301** (by Isaac), A bill to be entitled An Act relating to the creation of the Driftwood Conservation District; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes. (Cain, Rinaldi, Shaheen, Simmons, Springer, Stickland, and Zedler recorded voting no.)

#### **Amendment No. 1**

Representative Isaac offered the following amendment to **CSHB 4301**:

Amend **CSHB 4301** (house committee printing) as follows:

(1) On page 6, strike lines 13 through 18 and substitute the following: the injection is authorized by a commission rule or permit under Chapter 27, Water Code.

(2) Strike page 7, line 21 through page 8, line 2 and substitute the following:

Sec. 7982.107. LIMITATION ON GROUNDWATER USE. In providing water services to users in the district, the district may not, except in emergency situations:

(1) develop groundwater on land owned by the district for use as a potable water source; or

(2) purchase or lease the rights to groundwater underlying land inside the district for use as a potable water source.

Amendment No. 1 was adopted. (Springer recorded voting no.)

**CSHB 4309** (by Isaac), A bill to be entitled An Act relating to the creation of the Driftwood Municipal Utility District No. 1; granting a limited power of eminent domain; providing authority to issue bonds; providing authority to impose assessments, fees, and taxes. (Cain, Rinaldi, Shaheen, Simmons, Springer, Stickland, and Zedler recorded voting no.)

#### **Amendment No. 1**

Representative Isaac offered the following amendment to **CSHB 4309**:

Amend **CSHB 4309** (house committee printing) by striking page 6, line 27 through page 7, line 8 and substituting the following:

Sec. 7983.107. LIMITATION ON GROUNDWATER USE. In providing water services to users in the district, the district may not, except in emergency situations:

(1) develop groundwater on land owned by the district for use as a potable water source; or

(2) purchase or lease the rights to groundwater underlying land inside the district for use as a potable water source.

Amendment No. 1 was adopted. (Springer recorded voting no.)

(3) collaborating with the department to develop an outreach plan for children and youth in the conservatorship of the department to promote awareness of the ombudsman.

(b) If a child or youth in the conservatorship of the department contacts the ombudsman by telephone call to report a complaint under this subchapter, the call shall be transferred directly to a person employed by the division of the ombudsman created under this section.

#### SB 213 - STATEMENT OF LEGISLATIVE INTENT

REPRESENTATIVE HOWARD: This is just a few clarifying questions for legislative intent. I appreciate the amendment that you just laid out, which is what this is really related to. So my understanding is that the Office of the Ombudsman for children and youth in foster care is currently housed at Health and Human Services and that your amendment would move the Office of the Ombudsman for foster care youth to the Department of Family and Protective Services. Is that correct?

REPRESENTATIVE J. RODRIGUEZ: That's correct, Ms. Howard.

HOWARD: I also understand, as you pointed out, that Senator Kolkhorst, who created the foster care ombudsman last session, filed a rider that would allow the department to allocate an additional 3.0 FTEs in each fiscal year of the biennium

for the agency's Office of the Ombudsman to increase the number of youth served by this office and that rider was adopted to Article II of the budget. Is that your understanding?

J. RODRIGUEZ: That's also correct, yes, Ms. Howard.

HOWARD: I worked on a rider for an additional 3.0 FTEs in each fiscal year for the foster care ombudsman, but unfortunately that one was not in Article II. I'm still concerned about the office having the resources it needs to perform the work we are requiring, especially given all of the changes to the department that we made this session. Do you know if the 3.0 additional FTEs that the department will allocate as a result of Senator Kolkhorst's rider will be used for the foster care ombudsman's office as opposed to the other activities the ombudsman's office oversees?

J. RODRIGUEZ: That is my understanding, that they will be used for what's intended with respect to that particular rider for children in foster care.
