Because of the current restrictions on the use of HOT taxes, the city has amassed millions of unspent dollars in their HOT tax fund. Simultaneously, the city has become a major host for the NCAA and UIL championship events and would like to expand their ability to host additional events by constructing a multi-use sports complex. The use of their HOT taxes will limit bond indebtedness on the property owners and residents of the city for such a project. The city is in exceptional financial condition with strong transparent governance.
