INTRODUCTION OF GUESTS

The chair recognized Representative S. Davis who introduced Nobel Laureate Dr. James P. Allison and his wife, Padmanee Sharma, Dr. Peter W.T. Pisters, and Chancellor James Milliken, speaking as follows:

Members, today we are congratulating Dr. James P. Allison, who is on the dais with us, for receiving the 2018 Nobel Prize in Medicine for inventing a successful type of cancer immunotherapy that treats the immune system rather than the tumor. Also on the dais joining Dr. Allison today is his lovely wife and fellow researcher, Dr. Padmanee Sharma; Dr. Peter Pisters, president of MD Anderson Cancer Center; and James Milliken, chancellor of The University of Texas System. Some of you may or may not know that Dr. Allison is, in fact, a native Texan whose research and work, in many ways, is revolutionizing cancer research and cancer care. Dr. Allison's research of certain white blood cells that regulate a wide range of immune responses led to his discovery of how some proteins and some of those cells act as brakes on the immune system. Deactivating these proteins essentially releases the brakes and unleashes an immune attack against cancer. Many of us on the floor, including myself, have had personal experiences with cancer through family and friends. Many of us understand the tremendous impact this work has already had on some patients and some cases offering complete cures. We also understand the great hope and promise that immunotherapy offers to patients, both at MD Anderson and around the world.

Not least of which—and let me remind you—Dr. Allison is a CPRIT scholar. CPRIT has attracted 166 scholars and 11 companies to Texas from 20 states and seven countries, including from research hubs like Massachusetts, California, and North Carolina. CPRIT has also leveraged \$2.6 billion in non-state follow-on funding from its \$2 billion in contracts. In total, CPRIT has helped start, expand, or attract 30 biotech companies in Texas, creating more than 10,000 permanent jobs in 2018 alone. CPRIT has also helped detect more than 14,000 cancer precursors and almost 3,500 cancers. If you received the e-mail earlier this morning, Dr. Zerwas has filed **HB 39** which extends CPRIT beyond its 2023 sunset and also **HJR 12** to increase CPRIT's bonding authority to \$6 billion. I hope that you will all consider coauthoring both of those pieces of legislation. They are both in the clerk's office awaiting your signatures. It is my hope that as we debate the future of CPRIT we keep in mind the caliber of individual talent and work that was encouraged to return home to Texas because of the Texas Legislature's commitment to making cancer history. Mr. Speaker and members, please help me congratulate Dr. Allison and welcome our guests to the Texas Capitol.
