( ) The executive commissioner, in consultation with the Department of State Health Services, shall adopt rules necessary to implement this section.

(3) Reletter subsections of added Section 42.067, Human Resources Code, and cross-references to those subsections as necessary.

Amendment No. 1 was adopted.

(1) is limited to persons employed by the owner, operator, or their authorized agents;

(2) has a foundation designed and stamped by a professional engineer;

(3) is verified as code compliant by a third-party professional engineer;

and

(4) satisfies any applicable state, municipal, and local safety requirements.

(2) Renumber remaining sections appropriately.
