CSHB 226 ON SECOND READING
(by Krause, Murr, Goldman, Moody, et al.)

CSHB 226, A bill to be entitled An Act relating to the creation of a commission to review certain penal laws of this state and to make certain recommendations regarding those laws, to criminal offenses previously compiled in statutes outside the Penal Code, to repealing certain of those offenses, and to conforming punishments for certain of those offenses to the penalty structure provided in the Penal Code; increasing the punishment for the criminal offenses of sedition, sabotage, and capital sabotage; imposing a civil penalty.

HB 2846 ON SECOND READING
(by Larson, Metcalf, Zerwas, Price, and E. Thompson)

HB 2846, A bill to be entitled An Act relating to the sale of the Allens Creek Reservoir project.

Amendment No. 1

Representative Farrar offered the following amendment to **HB 2846**:

Amend **HB 2846** (house committee printing) by striking all below the enacting clause and substituting the following:

SECTION 1. Article 1, Chapter 1291, Acts of the 76th Legislature, Regular Session, 1999, is amended by adding Section 1.07 to read as follows:

Sec. 1.07. (a) Notwithstanding any other provision of this article, not later than January 1, 2020, the City of Houston shall enter into a contractual agreement with the Brazos River Authority to transfer to the Brazos River Authority all of

the city's ownership interests in the Allens Creek Reservoir project, including all required water right permits, along with the responsibility to construct the project in accordance with all associated statutory requirements and deadlines.

(b) Construction of the reservoir is subject to the Brazos River Authority obtaining all necessary federal permits.

(c) In addition to other necessary provisions, the contractual agreement described by Subsection (a) must include provisions for the transfer of an amount not to exceed \$23 million from the Brazos River Authority to the City of Houston.

SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2019.

(3) On page 1, line 7, strike "~~one~~ two years" and substitute "two years [~~one year~~]".

(4) On page 1, between lines 9 and 10, insert the following:

(2) six months after the completion of a dry hole on the unit; or

(3) six months after cessation of production from the unit.

HB 102, A bill to be entitled An Act relating to a school district assigning a mentor teacher to a new classroom teacher.

Amendment No. 1

Representative Bernal offered the following amendment to **HB 102**:

Amend **HB 102** (house committee report) as follows:

(1) On page 1, line 6, between "(f)," and "and", insert "(f-1),".

(2) On page 1, line 9, strike "two school years" and substitute "one school year".

(3) On page 1, line 10, strike "on the first day" and substitute "not later than the 30th day".

(4) On page 1, line 11, following the underlined period, insert "A district must agree to assign a mentor to a new classroom teacher for at least two school years.".

(5) On page 2, lines 15 and 16, strike "at least once a week for an individual mentoring session lasting at least 45 minutes, with".

(6) On page 2, line 17, strike "of meeting time".

(7) On page 2, line 17, strike "The" and substitute the following: "Observations of the mentor by the classroom teacher being mentored or of the classroom teacher being mentored by the mentor may count toward the 12 hours of meeting time required for the semester. Except as provided by Subsection (f-1), the".

(8) On page 2, between lines 26 and 27, insert the following:

(f-1) Subject to approval by the agency, in determining the topics to be addressed in the mentoring sessions, a school district may create an appropriate curriculum that meets the district needs.

HB 2129 ON SECOND READING

HB 2129, A bill to be entitled An Act relating to the extension of the expiration of certain parts of the Texas Economic Development Act.

CSHB 1409, A bill to be entitled An Act relating to the qualification of land for appraisal for ad valorem tax purposes as timber land or restricted-use timber land.

CSHB 809, A bill to be entitled An Act relating to measures to assist students enrolled at public institutions of higher education who are homeless or who were formerly in foster care.

HB 692, A bill to be entitled An Act relating to the suspension of a student who is homeless from public school.

CSHB 444 ON SECOND READING**(by Meyer)**

CSHB 444, A bill to be entitled An Act relating to increasing the criminal penalties for insider trading and other misuse of official information by public servants.

CSHB 444 was passed to engrossment.

HB 71 ON SECOND READING**(by Martinez)**

HB 71, A bill to be entitled An Act relating to the creation of regional transit authorities; granting the power of eminent domain; providing authority to issue bonds and charge fees; creating a criminal offense.

Amendment No. 1

Representative Martinez offered the following amendment to **HB 71**:

Amend **HB 71** (house committee printing) as follows:

(1) On page 5, strike lines 11-12.

(2) Strike page 6, line 25, through page 7, line 3, and substitute the following:

(c) An authority may acquire by eminent domain any interest in real property, including a fee simple interest, except the right of eminent domain may not be exercised:

(1) in a municipality without the approval of each proposed acquisition by the governing body of the municipality or in an unincorporated area without the approval of each proposed acquisition by the commissioners court of the county in which the property to be condemned is located; or

(2) in a manner that would:

(A) unduly impair the existing neighborhood character of property surrounding, or adjacent to, the property to be condemned;

(B) unduly interfere with interstate commerce; or

(C) authorize the authority to run an authority vehicle on a railroad track that is used to transport property.

(3) On page 7, strike lines 22-24, and substitute "without the provider's permission.".

(4) On page 8, line 11, between "section" and "is", insert "and approved by resolution of the appropriate municipal governing body or commissioners court".

(5) On page 9, line 20, between "(d)" and "The", insert "This section does not limit the state's power to regulate fares, tolls, charges, or rents imposed by an authority or other compensation authorized under this section.".

(6) On page 9, line 21, between "chapter" and "not", insert ", however.".

(7) On page 15, line 9, between "(1)" and "\$1", insert "not more than".

(8) On page 15, line 10, between "(2)" and "\$2", insert "not more than".

(9) On page 15, line 11, between "(3)" and "25", insert "not more than".

(10) On page 18, between lines 25 and 26, insert the following:

Sec. 463.1055. PROCUREMENT RULES. (a) The executive committee may adopt and enforce procurement procedures, guidelines, and rules:

(1) defining the terms in and implementing Sections 463.106 and 463.107; or

(2) covering:

(A) the appointment of contracting officers;

(B) the solicitation for and award of contracts, including the electronic transmission of bids and proposals and the use of the reverse auction procedure, as defined by Section 2155.062, Government Code;

(C) the resolution of protests and contract disputes;

(D) foreign currency transactions and conversions and foreign exchange rate risk management; or

(E) other aspects of the procurement process for domestic and international contracts.

(b) Sections 463.106 and 463.107 and the procedures, guidelines, or rules adopted under this section confer no rights on an actual or potential bidder, offeror, contractor, or other person except as expressly stated in the procedures, guidelines, or rules.

(c) A procurement procedure, guideline, or rule covering the electronic transmission of bids and proposals must provide:

(1) for the identification, security, and confidentiality of an electronic bid or proposal;

(2) that an electronic bid or proposal is not required to be sealed; and

(3) that an electronic bid or proposal remains effectively unopened until the appropriate time.

(11) Strike page 19, lines 10-15, and substitute the following:

(1) the aggregate amount involved in the contract is \$50,000 or less;

(12) On page 19, at the end of line 26, add "or".

(13) Strike page 20, line 13, through page 21, line 9, and substitute "of the authority's financing activities."

(14) On page 23, between lines 11 and 12, insert the following:

Sec. 463.1535. APPROVAL OF MUNICIPALITY. The location of a station or terminal complex in a municipality or in the extraterritorial jurisdiction of a municipality must be approved, as to conformity with the comprehensive or general plan of the municipality, by a motion, resolution, or ordinance adopted by the governing body of the municipality.

(15) On page 24, between lines 11 and 12, insert the following:

(c) A bond that has a maturity longer than five years from the date of issuance may not be issued by an authority until an election has been held and the proposition proposing the issue has been approved by a majority of the votes received on the issue.

(d) Subsection (c) does not apply to:

(1) refunding bonds;

(2) bonds described by Subsection (a)(2); or

(3) commercial paper notes having maturities of 270 days or less that are authorized to be issued and reissued from time to time under a commercial paper program in a maximum principal amount that the chief financial officer certifies, based on reasonable estimates of pledged revenue, can be repaid in full

(e) A commercial paper program described by Subsection (d)(3) may not be continued beyond five years unless, before issuing any note with a maturity exceeding five years from the date of the initial authorization of the program or five years from the date of any new certification, the chief financial officer provides a new certification that the maximum principal amount of the program, based on reasonable estimates of pledged revenue, can be repaid in full within five years after the date of the most recent new certification, taking into consideration any other bonds or notes having a prior or parity lien on the pledged revenue.
