**INTRODUCTION OF GUESTS**

The chair recognized Representative Bucy who introduced family members of Dr. Robert Keith Pendergrass, speaking as follows:

Members, we're here to remember a great Texan, a constituent of my district, Dr. Robert K. Pendergrass—my grandfather or "Nandy" as we called him. I'm joined today by my grandmother Mary, who's next to me. Up on the dais we have my mother, Virginia; my sister, the oldest grandchild, also Virginia; my uncle Keith; and my uncle Henry. We also have other members of the family with us in the gallery today. Winning my race for state representative is one of the greatest experiences of my life. The only sad part about it was to not have my grandfather with us to be a part of the celebration. He passed away last June. So I want to take this opportunity to bring him into this room with all of us today. My grandfather was the rock of our family. He was always there to hold us up and give us support. He gave us the tools through education and inspiration to all become strong people in our own lives. He left behind an amazing wife, four educated children with four talented spouses, nine grandchildren including a Texas state representative, albeit a democrat—I apologize, Grandfather—and three great-grandchildren. This is the legacy of a life well lived.

He spent 93 years on this earth. How do you sum up such a wonderful life? You can speak of his love of God, family, and Texas. You can speak of his military service—how at 17 years old, he signed up with his mother's signature and joined the Army the day after Pearl Harbor and how when asked if he would serve his country again in Korea, he immediately said yes. You can speak of his medical practice, which started out in small-town Pittsburg, Texas, where he often would trade medical service for dinners or other gifts in lieu of money. You can speak of his service to the Lone Star State, where in his own community of

Pittsburg, he and his family faced death threats because he ran for president of the school board on the promise of desegregating the schools—something he successfully did. Or of his time appointed to run the Texas Medicaid program initially by Governor Clements and then again by Governor White—something he was very proud of.

As you can see, you can tell many stories of him with his family whom he loved very much. For me, I think a lot of the personal interactions that I shared with him. I'm reminded of the time he told me after yet again a poor performance in Spanish class, which was his favorite subject, that a mind is a terrible thing to waste, John. I think of the tales of Texas history and his hero Sam Houston, who watches over us in the gallery, and of their shared lived philosophy to do right and risk the consequences—something my grandfather always did. I think of me nervously walking into their house in 2013 to sit them down and tell them that I was going to run for state representative, and not only did I need their support, I wanted him to serve as my treasurer, which he cheerfully accepted. And I think of how when I lost that election, he wrote me a letter of encouragement to continue to strive to serve.

Late in life, he wrote us a book for all the family members. In it he shared his life story and many kind of farewells to each of us. In this book he also spoke of leadership of Texas, and he spoke to all of us that are here today. He said, "Texas needs victors, and I hope that you will be one." He had such high hopes for us. He believed that we could bring our differences and still sit at the same table, that we could disagree without being disagreeable, and that we could always put the people of Texas first. My grandfather, Dr. Robert K. Pendergrass, spent 34,251 days on this earth, 34,000 sunrises and sunsets, 34,000 days working to make this world a better place. He told me many years ago that he had devoted his life to education, to learning and to spreading knowledge, to being a teacher of anyone that would listen. He believed that through the passage of knowledge from one person to another and then to another, as long as our knowledge is shared, one person never truly dies. Our family was so very blessed to have him, and I will continue to share his stories and make sure that the next generations and the ones after that will know him, and he will live forever. I want to thank you, Grandfather, for a life well lived. We love you very much.
